

Sealed bids are invited on percentage rates basis (above or below the estimated cost mentioned below) from the contractors having valid license of constructor / operator in the relevant category issued by Pakistan Engineering Council Bidding documents can be purchased from the office of the undersigned during office hours, on any working day up to **06.06.2024** (closing date), on written request on the letter head of the Company/Firm etc, along with the following documents.

1. Valid license as constructor / operator in the relevant category issued by Pakistan Engineering Council.
2. Documents showing the Company/Firm's name on the Active Tax Payer's list displayed on the FBR website.
3. Non Refundable tender cost amounting to Rs.3,000/- (Rupees: Three Thousand Only).

The bids in sealed envelope should be dropped in the tender box, in the office of the undersigned on **07.06.2024** up to **2.00 P.M.** The respective bids will be opened on the same day at **02.30 P.M.**, in the presence of contractors or their authorized representatives. Other terms and conditions can be seen in the bidding documents.

TERMS & CONDITIONS.

1. Tender documents can be purchased on production of proof of being proprietor of the firm or their authorized representative possessing valid power of attorney.
2. No bidding document will be sold/issued after the closing date.
3. In case of public holiday, the receipt and opening of tenders will be the next working day.
4. No bidding document will be issued through *email, whatsapp* etc.
5. Bids security @ **05%** (Five percent) of bid price, in the form of **Deposit at call**, (CDR) in the name of Executive Engineer, Central Civil Division No. II Pak PWD Lahore, from any scheduled bank of Pakistan, should be attached along with the sealed bid, otherwise bid will be rejected.
6. The documents of the firm, CNIC, NTN, valid Pakistan Engineering Council License etc should be available with the intending contractors at the time of purchase of tenders, failing which bidding documents will not be issued.
7. Invitation to bid is also available at PPRA website www.ppra.org.pk.
8. If the bid amount of successful bidder is seriously unbalance in relation to the detailed estimate, the bidder shall have to furnish additional performance security equal to the difference of estimated cost and total bid amount in the shape of bank guarantee duly issued by any schedule bank of Pakistan besides furnishing detailed price analysis to demonstrate internal consistency of his rates as per Clause IB.28.4 of bidding documents.
9. Under clause 33 (1) of Public Procurements Rules 2004, the undersigned reserves the right to reject all bids or proposals, at any time, prior to acceptance.
10. The submission of bids by the contractor implies that he is fully conversant with the site of work, scope of work and all the terms & conditions, laid down in the bidding documents.
