Pakistan Agricultural Research Council (PARC) invites sealed bids (Single Stage One Envelope) through E-PADS from Original Seed Distribution companies ,Authorized firms / companies registered with FSC&RD, GST/Income Tax Department GOP, PPRA E-PADS Portal and having valid NTN for Procurement of Certified Seed of Mung & Mash for distributed among farmers across the country on 50% and 100% subsidy scheme to support national Pulses production under PSDP project titled "Promoting Research for Productivity Enhancement in Pulses for 2024-2025.

The eligible firms, Original Seed Distribution companies , & companies those authorized and capable, are to participate in bidding process on the terms & conditions as per detail specifications mentioned in the tender document. The tender document can be purchased from PARC Room # 231 (2nd Floor) on any working day during office timing, Monday to Friday from 21-05-2025 on written request of the firm/company letter head/pad with firm registration certificate and GST & NTN along with pay order / bank draft amounting to Rs.5,000/- (Non-Refundable) drawn in favor of PARC, Islamabad. Electronic Request for Proposal document containing detailed requirements, terms & conditions is available for the registered bidders on EPADS at www.eprocure.gov.pk


Bidders who may fulfill and abide by the prescribed terms & conditions contained in tender document may submit their bids on using E-PADS portal and also submitted hard copy (technical and financial in Separate envelope) in the office of Directorate of Procurement, PARC Room # 231, as per format on or before 06-06-2025, by 1100 hours positively and bids will be opened on the same day at PARC HQ, Islamabad at 1130 Hours in presence of bidders or their nominated representatives who choose to be present. No tender will be sold on date of opening of tender. The items will be delivered at PARC HQ, Islamabad. The quoted rates/bids shall be valid up to 31-12-2025.

Each bid should be accompanied with 2% earnest money of quoted bid amount in shape of bank draft or pay order in favor of PARC Islamabad. The conditional bids or the bids without earnest money or found less earnest money shall not be entertained/accepted as per PPRA Rules.

The payment of all taxes is the responsibility of the firms. PARC reserves the right to reject any or all bids proposals or may cancel the tender at any stage prior to acceptance of a bid or proposal. However PARC shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of bids / proposals, but is not required to justify those grounds. PARC may decrease or increase in the quantity of items or may revise it as may deem appropriate.
