MEPCO invites sealed bids on **Single Stage-Single Envelope** bidding procedure, from eligible firms under National Competitive Bidding (NCB) basis in accordance with Provisions of PPRA Rules.

ELIGIBILITY FOR TENDER-1

- This Invitation for Bids is open to all Bidders complying the following requirements: -
- a) Pakistan Engineering Council valid certificate with at-least Category **C-6** having Specialization Code **CE-10** must be provided.
- b) Participation in at least two contracts that have been successfully completed within the last ten (10) years and that are similar to the proposed scope of work (The bidder will submit completion certificate of the projects along-with supporting documents like work order, BOQ etc.).
- c) The contractors are required to submit their registration for sales tax with Punjab Revenue Authority.
- d) Identity Card of Contractor / Managing Partner / Director of the firm.
- e) Bidding documents will be issued only to the owner of the firm OR representative holding authority letter of the firm.
- f) Income Tax Returns for last two years.

ELIGIBILITY FOR TENDER-2

- a) The contractors are required to submit their registration for general sales tax with Punjab Revenue Authority.
- **b)** Identity Card of Contractor / Managing Partner / Director of the firm.
- **c)** Bidding documents will be issued only to the owner of the firm OR representative holding authority letter of the firm.
- d) Income Tax Returns for last two years.

- Eligible Bidders may obtain further information, inspect and acquire the Bidding Documents from the Office of **Project Director (GSC) MEPCO, Multan up-to** 12.06.2024 for tender.
- A complete set of Bidding Documents may be purchased by any interested bidder, meeting with the eligibility / qualification criteria, on submission of a written application to the above office and upon payment of a non-refundable fee of Rs. 3,000/- (Rupees Three Thousand Only) for each tender.
- All bids must be accompanied by a Bid Security (3% of Bid Amount) in favor of Project Director GSC MEPCO of any scheduled bank and shall be valid 28 days beyond bid validity. The bid shall be valid for 150 Days.
- The bids will be opened at the office of **Chief Engineer (Dev.) PMU MEPCO Multan** in the presence of bidders / bidder's authorized representatives who choose to attend the tender.
 - > Tender rates and amounts should be filled in figures as well as in words. Tenders documents should be signed as per general directions given in the tender documents.
 - > All the procurement will be done according to PPRA Rules-2004.
 - > Conditional / Electronic Bid shall not be permitted.
- > The bids covering partial and incomplete work shall be rejected.
