- a) Pakistan Engineering Council valid certificate with at-least Category **C-5** having Specialization Code **CE-10** must be provided.
- b) Participation in at least two contracts that have been successfully completed within the last ten (10) years and that are similar to the proposed scope of work (The bidder will submit completion certificate of the projects along-with supporting documents).
- c) The contractors are required to submit their registration for sales tax with Punjab Revenue Authority.
- d) Identity Card of Contractor / Managing Partner / Director of the firm.
- e) Bidding documents will be issued only to the owner of the firm OR representative holding authority letter of the firm.
- f) Income Tax Returns for last two years.
- Eligible Bidders may obtain further information, inspect and acquire the Bidding Documents from the Office of **Project Director (GSC) MEPCO, Multan up-to 12.06.2024** for tender.
- A complete set of Bidding Documents may be purchased by any interested bidder, meeting with the eligibility / qualification criteria, on submission of a written application to the above office and upon payment of a non-refundable fee of Rs. 3,000/- (Rupees Three Thousand Only) for each tender.
