1. The National Highway Authority intends to hire/ engage a Short-Term Consultant (Engineering Organization/ Firm) for “Consultancy Services for Third Party Review of PC-1 Of Electrical & Mechanical Works of Lowari Tunnel Project (Short-Term Consultant)”.

Proposals are invited from reputable Consultants (Engineering Organizations/ Firms) having valid Pakistan Engineering Council (PEC) registration certificate in relevant field alongwith enlistment on active Tax Payer List of Federal Board of Revenue and the detail eligibility criteria mentioned in the RFP document.
