- 1. Military Accountant general's Office (hereinafter called MAG) invites sealed bids from the registered firms for purchase of the different items of Stationery as per specification attached Annex "A", "B", "C"&"D".
- 2. You are required to submit your sealed bids, which will bear word "CONFIDENTIAL" and "TENDER FOR PROCUREMENT OF COMPUTER/OFFICE STATIONERY/MISC & ELECTRIC ITEMS FOR MAG OFFICE RAWALPINDI"
- 3. Purchase Committee reserves the right to increase or decrease the quantity or may cancel the tender altogether.

4. DELIVERY SCHEDULE

The stationery items mentioned at Annexure "A", "B", "C" & "D" shall be supplied within 03 days of issuance of supply order. The urgent demand shall be arranged within same day.

PENALTY:-

For failure to comply with the delivery schedule of purchase Order (s), penalty will be imposed as under:-

1% of the cost of entire purchase order or of such equipment as remains unsupplied/Un-completed for every day upto maximum of 5% for 10 days exceeding the delivery period.

If the items are not supplied even after payment of penalty for 10 Consecutive days MAG reserves the right to cancel the purchase order and to purchase required items from elsewhere at risk and cost of the defaulting Supplier.

- 5. Price must be quoted in Pakistani currency (inclusive of all taxes and duties), indicating unit price and total bid price. Prices must be quoted for all the options.
- **6.** Price must be quoted including all charges like handling, loading, and transportation and unloading of the equipment.

7. Quoted Price shall be valid for 12 Months. However, any subsequent change taxes and duties as notified by Federal Board of Revenue will be given due consideration.

8. **EARNEST MONEY:-**

The Bidder shall furnish the Bid security (Earnest Money) as under for a sum equivalent to 5% of the total tender price of items as per forms of Bid given in this Tender document in the form of call deposit receipt in the name of DDO MAG Kashmir Road Rawalpindi.

Any bid not accompanied by Earnest Money shall be rejected without any right of appeal.

Part earnest money or crossed cheque/bank guarantee as earned money is not acceptable.

In case of cancellation of purchase order due to default by the supplier the earnest money shall be forfeited.

9. PAYMENT:-

Payment of the total value of the Bill/Purchase Order will be released after completion of the delivery in accordance with the Purchase Order.

10. <u>DEADLINE FOR SUBMISSION OF BIDS :-</u>

All bids must be delivered in the office of undersigned on or before the prescribed deadline of 11:00 AM on 23 / 07 /2024.

11. LATE PROPOSALS:-

Any bid received after the prescribed deadline will be returned unopened to the Bidder.

12. OPENING OF BIDS:-

The Purchase Committee will open the bids at _11:30 AM as on _23/_07/2024, in the presence of bidders/representatives who like to attend.

13. EVALUATION:-

Bidder(s) who does not qualify cannot challenge the findings of the evaluation or ask for reasons of disqualification.

14. INSPECTION AND TESTS :-

Purchase Committee shall have the right to inspect and/or test the samples of the items to be purchased, the Computer/Office Stationery to confirm their conformity to Purchase Order(s) specifications.

If any inspected items fail to conform to the specification, purchase committee shall reject it and the Supplier shall either replace the rejected items or make all alterations necessary to meet specifications. All costs incurred on such items shall be borne by the supplier.

Replacements/alterations shall be entirely borne by the supplier. Failing to do so the Purchase Order(s) will be cancelled and all retained value of the defaulter will be forfeited.

15. WARRANTY:-

The Supplier shall warrant that all items having specific life period, items supplied under the Contract (s) shall have no defect arising from design, materials or workmanship or from any act or omission of the Supplier, that may develop under normal use of the supplier items under the conditions prevailing at final destination.

Procuring Agencyshall promptly notify the Supplier in writing of any claims arising under this warranty. Upon receipt of such notice, the Supplier shall repair or replace the defective equipment or parts thereof without cost immediately.

Period of Comprehensive warranties and maintenance with labor and material cost shall be for all quoted equipment. During the warranty period due to any reason if, the Supplier failed to rectify the problem then item shall be repaired or replaced thereof and the Earnest Money shall be forfeited.

- **16.** Quantities mentioned at Annexure "A", "B", "C" & D" may be increased or decreased which will be at the sole discretion of Procuring Agency.
- **17.** All Proposals must include:

Company's profile, list of clients with telephone Nos and addressCopies of Income Tax and Sale Tax Registration Certificates.

- **18.** i. Copies of technical material/brochures of all the quoted equipment.
 - **ii.** Certificate from the Principal that the vendor is sole Distributor/Authorized Dealer/Authorized Re-Seller etc. (whereapplicable).
 - **iii.** Affidavit (on legal paper) to the effect that the firm has never been black-listed by any agency of government/semi government/autonomous or business concern.
