## TENDER FOR LINE LOSS STUDY OF TESCO T&D NETWORK

1. Established on the 2nd of July 2004, **Tribal Areas Electricity Supply Company (TESCO)** stands as a State Owned Enterprises (SOE) and a Public Limited Company entrusted with the pivotal task of supplying electricity to a vast network of consumers spanning over 443,260 entities across the 7 Merged Tribal Districts, formerly known as FATA, and all corresponding FR-Regions with FATA.
2. TESCO is using PSSE software for the expansion and upgradation of TESCO Transmission and Grid System while for Distribution System planning, TESCO is using SynerGee Software.
3. TESCO intends to assess the technical loss value as well as transformation losses for its T&D network by conducting the technical loss study. The firms, having previous experience of similar nature, are invited to submit in sealed envelope Request for Proposal (RFP), through a Single Stage Two Envelope (1S2E) process with the following conditions.
  - a. PEC registration in similar category along with registration certificate.
  - b. Min 5 Years experience in Power Industry for the similar job.
  - c. Similar Nature Projects details, Cost of Projects, Clients Profile and number of similar projects completed in last 10 years.
  - d. Financial Position of the firm and its subsidiaries. (last 3 years Audited Statements are required)
  - e. Profile of the Professionals along with their experience in the similar nature job.
  - f. Project Completion or performance certificates of previous completed project of similar nature from the client.
  - g. Copy of NTN, GST and KP Tax registration.
  - h. All other terms and conditions are parts of the bidding document.
4. Bidding Documents will be issued to eligible and interested firms after submission of all required documents as mentioned from (a-h) above.
5. The RFP will be submitted under 1S2E PPRA rules with 1 original + 4 copies of Technical and 1 Copy of Financial Proposals in Separate Sealed Envelope with clear mentioning on each envelope as "**Technical Proposal**" and "**Financial Proposal**". Both proposals will be sealed in a common envelope.
6. The Financial Proposal Envelope shall also be written "Open after completion of the technical evaluation"
7. 2% Bid security of total value of bid must be attached with the proposal in the Name of Chief Executive Officer TESCO from a schedule bank of Pakistan in shape of bank draft or Pay order which is valid 28 days after the validity of RFP. The bids proposal will be valid for a period of 120 days after the last date of submission, which is extendable on the expiry of this period through mutual consent. Non-compliance will lead to rejection of RFP.
8. The bidding documents can be collected after payment of Rs 5000/- (non-refundable) from undersigned office.
9. Prebid meeting will be held on 4th June. Firms having tender deposit fee receipt will be invited for pre-bid meeting personally or through ZOOM.
10. RFP must be submitted on or before 26th June 2024 at 11:00 hrs. The bid will be opened on same day at 11:30 hrs. in the office of Director (MM) TESCO at Wapda House Shami Road Peshawar. The financial proposals will remain sealed and will only be opened for those firms which will qualify the minimum technical score criteria. The financial proposals of non-qualified firms will not be entertained and will be returned without opening.
11. Proposals having short comings or incomplete in any respect will be rejected.
12. Any proposal received after due date and time will not be accepted.
13. Electronic Proposal will not be acceptable.
14. Any Conditional proposal or proposal without security will not be acceptable.
15. TESCO reserves the right to accept / reject any or all the proposal without assigning any reason and its decision shall be final and binding.
