Those eligible Firms / Bidders / JV who has executed similar assignments and interested to participate in Request for Proposal (RFP) are required to submit sealed Request for Proposal (RFP) with following information:

 - Up-To-Date Registration copy of NTN, GST / Income Tax (active tax payer) and Sindh Revenue Board (SRB).
 - Other terms & conditions are mentioned in Bidding Documents.

- The RFP procedure will be based upon "Single Stage One Envelope" under National Competitive Bidding (NCB) basis in accordance with the Provisions of PPRA Rules-2004 amended up to date.
