1. <u>SUBMISSION OF TENDER</u>

1.1 Please quote as per following single stage two envelope methods. You are required to quote in two parts:-

Part I "Technical Offer": It should exclusively give technical details and literatures/brochures of the offered store; validity date; delivery schedule; and signed undertaking given on the schedule to this Tender Enquiry. It must not indicate price, costs etc. Advance sample must be provided with technical Offer.

Note: it must not indicate price, costs etc.

- a) Part II "Commercial Offer": It should indicate the commercial terms e.g. price, terms of payment, mode of payment, mode of supply. Each part should be placed in a separate sealed cover. The envelopes should be inscribed with: Part I "Technical Quotation without Price" and Part II "Commercial Quotation with Price".
- 1.2 Only one tender should be included in one envelope. The outside of the envelope should be inscribed with:-

2.0 GENERAL INSTRUCTIONS:

- 2.1 The quotation must remain valid for at least 90 days from the date of opening of tenders.
- 2.2 The quotation should hold good for any reduced or enhanced quantity without notice.
- 2.3 Conditional offers or alternative offers are likely to be ignored.
- Quotations should be based on "Free Delivery" at Packages Factory, (Adjacent to POF Barier 01), Sanjwal Cantt.
- 2.5 The suppliers registered with Sales Tax Deptt are only eligible to participate in the T.E. The competitive supplier shall have to furnish Sales Tax Invoice and Professional Tax Clearance Certificate.

3.0 TENDER FEE:

The Tender must be accompanied by a non-refundable fee of rupees Rs. 2,500/- by means of a Pay Order or Call Deposit Receipt in favour of CEO / MD Wah Industries Ltd., Quaid Avenue, Wah Cantt. The Tender fee must be made part of Technical offer.

- 4.1 Bid Money at the rate of 2% of the quoted value should accompany in the shape of Pay Order or Call Deposit Receipt issued from a Scheduled Bank drawn in favour of CEO / MD Wah Industries Ltd. Tenders received without Bid Money will be rejected.
- 4.2 Bid Money of the unsuccessful bidder will be returned as soon as the scrutiny of the tenders is completed. Bid Money of the successful tenderers will be retained until the contract is finalized. Bid Money will be forfeited in case the quotation is withdrawn before the expiry of its validity date.
