Sealed tenders along with security earnest money Rs.500,000/- tender amount/cost in shape of call deposit from any scheduled bank in favor of Karakoram International University Gilgit should be reached in the office of the undersigned by June 05, 2024 (11:00 AM) by Registered courier, which will be opened in presence of the committee members and bidders at 11:30 AM on the same date.
