

06	List of Technical / Non-Technical staff along with their qualification on the pay roll of the consulting firm which can be verified if required.
07	Undertaking on stamp paper that firm in neither involved in any litigation or abandoned any work in any department, not blacklisted as a result and a certificate to the effects that all document Particulars / Information furnished are true and correct.
08	Conditional bid, will be not entertained.
09	International firms having joint venture with local firms are also eligible to apply.
10	Summary of the overall experience indication separately the details of similar assignment dully completed and in progress.
