Appropriate category PEC registered constructor may obtain the pre-qualification documents on payment of Rs. 5,000/- (Rupees Five Thousand Only) (PQ document charges and non-refundable) in form of Bank Challan on company's name /P.O. or D.D in favor of Project Director Sub Campuses Pishin & Khuzdar during office hours from 9 am to 2 pm ( Monday to Friday).
5. The request must clearly state "Request for Pre-qualification Documents" for "Establishment of SBK Women's University Sub-Campus Pishin & Khuzdar".
6. Incomplete /Conditional/ Telegraphic applications shall not be entertained. Authorized person of the company/firm shall sign application.
