1. The National Highway Authority intends to hire/ engage a Consultant (Engineering Organization/ Firm) for “*Consultancy Services for Feasibility Study (Techno Economic+Commercial) & Detailed Design for Addition of Lanes on Pindi Bhattian –Faisalabad-Multan Motorway (M-4) (292 KM Approx.)*”

Proposals are invited from reputable Consultants (Engineering Organizations/ Firms) having valid Pakistan Engineering Council (PEC) registration certificate in relevant field alongwith enlistment on active Tax Payer List of Federal Board of Revenue and the detail eligibility criteria mentioned in the RFP documents.
