## TERMS AND CONDITIONS

1. Bidders are required to submit rate of each brand and of each specification separately.
2. Each item will be evaluated separately.
3. In case of equivalent brand, bidder must provide equivalence features / Certificate.
4. Quoted rates are irrevocable and must be valid upto 31-12-2025.
5. Purchase order(s) will be placed for any number of items as per requirement basis on above quoted rates within above mentioned stipulated period.
6. SLIC may drop any/ all items and its no liability on the procuring agency.
7. Wheel balancing is included in the price.
8. Bidders should provide the name of firm, complete postal address, Telephone No, Fax No, Email address and web address (if any).
9. Bidders are required to upload their proposals on EPADS systems as per laid down PPRA procedure for single stage single envelop basis. All bids are required as per criteria and clearly marked as "Purchase of Tyres for Official Vehicles of State Life P.O Karachi".
10. Tender will be initiated on single stage single envelop basis. Proposal will be opened and downloaded from EPADS on the opening date and time as given in tender notice and after necessary evaluation list of qualified bidders will be uploaded on PPRA / SLIC website and EPADS system as well. **Registration with Relevant Tax Authorities NTN, GST (Mandatory, else bid will be rejected.** However, bid security in shape of pay order must be submitted at the address given in tender notice / document before closing time else tender will be rejected.
11. Bid Security in shape of Pay Order/Bank Draft of Rs.25,000/-, in favour of State Life Insurance Corporation of Pakistan. The same will be returned immediately to un-successful bidders after completion of formal procedure and to successful bidder after completion of time period i.e 31-12-2025.
12. The Most Advantageous Bid would be accepted.
13. All the bids must include G.S.T. and all other taxes, in case, these are not categorically shown, it is considered that quoted prices inclusive of all taxes.
