The tender documents can be received from the office of the undersigned on submission of written application on firms letter pad along with deposit slip of tender documents fee of Rs.3000/- against Head of Account No. **C03518 "Sale of other forms"** in any branch of NBP. The tender documents along with requisite documents must reach at office of the undersigned on or before the closing date and time mentioned above. Tender documents will be opened on the same day as schedule given above in presence of contractor or authorized representatives.

**GENERAL TERM AND CONDITIONS:-**

- I. Call deposit/Earnest money as mentioned above must be attached with the tender documents in form of demand draft/pay order of a scheduled bank in the name of Section Officer (Forest), Forest, wildlife & Environment Department GB.
- II. Tender with incomplete supporting documents shall not be accepted, and furnishing of incorrect information shall be liable to legal action.
- III. An affidavit on stamp paper of Rs. 100/- must be accompanied with the tender documents to the effect that the bidder has never been blacklisted by any Government/Semi-Government organization/PPRA and has No Litigation.
- IV. The firm/contractor winning the bid shall be bound to supply the items to Forest, Wildlife and Environment Department within one month from the date of issuance of supply order.
- V. The selected firm shall be bound to supply/provide/goods/services at rates quoted in tender during the financial year 2023-24.
- VI. Firms quoting inappropriate/irrational rates with respect to market rates shall not be considered.
- VII. The contractor must have his own shop/workshop to participate in the tender.
- VIII. Firm/contractor must have **experience** in the relevant field and supply orders/experience certificates must be attached with tender documents.
- IX. The procedure of single stage two envelopes shall be followed.
- X. Quotations must be computer typed. Hand-written quotations shall not be entertained.
- XI. The department reserves right to accept or reject the tender according to PPRA Rule-33(1).
- XII. The items which are not included in form/list shall be supplied by the contractor/firm from open market as per prevailing market rates.
- XIII. In case of vacation on the tender closing/opening date, the Tender proceeding will be held on the very next working day.
