## INVITATION TO BID

The Executive Engineer, Karachi. Central Civil Division No.III, Pak PWD, Karachi, invites sealed tenders, under Single Stage Single Envelope & on percentage rate basis for the work tabulated hereunder, from the Contractors/Firms registered with Income Tax & Sindh Revenue Board & having valid licence of Pakistan Engineering Council in appropriate category & field of specializations (C-5 or above).

- 2. A complete set of Bidding Documents containing detailed terms and conditions may be purchased by an interested eligible bidder on submission of a written application supported with requisite documents from the office of the undersigned upon payment of a non-refundable fees in cash. Tender documents will be issued to the proprietor of the Firm / Company or their authorized representatives having registered Power of Attorney.
- 3. In accordance with PPRA Rule-25; Bid Security i.e. fixed amount is required in shape of CDR, Pay Order, Bank Draft or Bank Guarantee in favor of undersigned by any schedule bank. The bidder will submit original bid security; dropping the tenders by bidders without requisite documents and original Bank Guarantee / CDR / Pay Order / Bank Draft will be reported for penal action under the rules and it will be treated NON-RESPONSIVE summarily. The time and schedule is narrated hereunder:

i) Issuance of Bidding documents upto: 10.06.2024 during office hours

ii) Dropping of Bidding documents: 11.06.2024 09:00 A.M. iii) Opening of Bidding documents: 11.06.2024 09:30 A.M.

4. In case bid cost is found abnormal below; the bidder will have to furnish additional performance security in the form of Call Deposit, Bank Draft or Bank Guarantee in an amount equal to the minus (-) variance with reference to Engineer's Estimate / Estimate Cost, within 3 working days from the date of opening of financial bids.

## **ELIGIBILITY CRITERIA:**

- 1. Method of Procurement:- Single Stage Single Envelope Procedure.
- 2. Firm must provide copy of valid CNIC & NTN Certificate.
- 3. Participating firm must be well established and registered with Government authorities FBR, SRB and Active on Tax Payer list (ATL).
- 4. Undertaking on Original Affidavit on Stamp Paper of Rs.100/- about the detail of litigations & black listing with any department that the firm/contractor is neither involved in any litigation with any Divisional Office of the Department and other Department nor abandoned any work black listed in any Department along with certificate / particular / information furnished are true and correct duly attested by Oath Commissioner.
- 5. Firm must provide financial audit reports for the last 3 years verifiable having satisfactory (ICAP) ratings (Audit report must be verifiable with bank statement details).
- 6. Similar nature of 03 Nos. Work / Projects successfully completed by the Bidder in last 03 years equal to NIT amount (Provide documentary evidence).
- 7. Similar nature of 03 Nos. Work / Projects complexity in-hand equal to NIT amount (Provide documentary evidence).
- 8. Account Maintenance Certificate.
- 9. Bank Credit Line Certificate Mandatory up to 50 Million.

10. Documents will be scrutinized by this office and no tender document will be issued without completing of all above mentioned eligibility criteria. In case of submission of fake information, and the same is proved then firm will be reported as per rule.
