Assistant Director Fisheries Gilgit invites the Sealed Tenders (Technical + Financial) under Regular budget current Financial Year 2024-25 and approved ADP Project titled "**Support to enhanced production through up-gradation and expansion of existing fish farmers and hatcheries in District Gilgit and promotion of small scale Fish farming**" for procurement of following trout fish feed, as per approved specification, from well reputed Firms /manufacturers/ authorized dealers/agents/suppliers and contractors for the FY 2024-25.

**TERMS AND CONDITIONS**

1. Sealed computerized tenders, application on letter heads of the firm along with attested copies of **Form "C"** with Deed of partnership should be reached to the Assistant Director Fisheries office Fatah Bagh near Communication and Works Secretariat Gilgit on or before the date & time mentioned against each and shall be opened in presence of bidders or their authorized representatives on the mentioned date, venue and time.
2. Bidder registered with FBR should submit only the attested copies of registration form.
3. Work experience in relevant field/ firm registration certificate must be attached with the bidding documents.
4. Two (2) % call deposit (CDR) (scheduled bank only) of the quoted bid in favor of Assistant Director Fisheries Gilgit is required along with financial proposals and the photocopy of same CDR must be attached with Technical Bid also.
5. The Assistant Director Fisheries reserve the right to reject all bids or proposal at any time prior to the acceptance of bid or proposal as prescribed under rule 33(1) of PPRA Rule 2004.
6. The interested bidders for trout fish feed should have authorized dealership from the relevant national trout feed producing agency/company (Original Dealership Certificate). The authorized dealership certificate from the producer company along with their registration documents (NTN/FBR) must be submitted with the Tender documents. The department has the right to verify the above documentations from the producer company directly.
7. The Department right to inspect, test and where necessary, reject the supplies even after arrivals at the mentioned delivery points. The supplier shall either replace the rejected feed/supply.
8. The bidder bound to deliver the Troutfeed throughout the hatcheries /production units of District Gilgit i.e kargah Trout Farm/Hatchery, Goru Trout Complex and Nalter Trout Farm.
9. Lot based bidding procedure will be adopted for the above mentioned tender/item.
10. Only computerized bid rates are acceptable, handwritten bid rates will be rejected in financial proposal.
11. The bidding criteria of "Single stage Two Envelopes" bidding procedure (Technical and Financial) as per Rule 36 (b) of PPRA Rules 2004 shall be applied.
  - (i) The bid shall comprise a single package containing two separate envelopes. Each envelop shall contain separately, the technical and financial proposal.
  - (ii) The envelopes shall be marked as "TECHNICAL PROPOSAL" and "FINANCIAL PROPOSAL" in bold and legible letters to avoid confusion. Initially, only the envelope marked "TECHNICAL PROPOSAL" shall be opened.
  - (iii) The envelope marked as "FINANCIAL PROPOSAL" shall be opened only after technically qualification of the firms; the qualifying marks of the technical evaluation will be decided by the tender committee.
12. In case of any unforeseen reasons on the bid submission and opening date, the tender shall be opened on the next working day at the same place/time.
13. The offered Bid for too below/ above the reasonable market rates shall be rejected.
14. The shortlisted contractor will bound to provide the required needful feed for financial year 2024-25 as per market rates which are not included in the tender documents.
