Bids will be opened on following schedule by the purchase Committee in presence of bidders / authorized nominee:-



f.	Repair / Maintenance of Vehicles	13-8-2024 at 1230 hrs

4. Bid received after the mentioned date and time will not be accepted. The Purchase Committee reserve the right to cancel all tenders as per present PPRA rules.

5. **Terms & Conditions.** The terms & Conditions are as under:-

- a. Tender(s) without earnest money of less than 02% of the estimated value will not be entertained.
- b. Items will be delivered on receipt of supply order, failing which the call deposit shall stand forfeited.
- c. Sample of items (Lab report of samples) should be deposited with the tender.

- d. The Bidding document of only registered firm /contractor /Supplier will be entertained.
- e. No such application will be entertained without earnest money mentioned in the tender documents.
- f. Bid without samples (Lab report of Dog Feed sample) will not be entertained and bidder will stand disqualified.
- g. Separate tender for each category must be offered mentioning Name of Category in bold letters on envelop
- h. Items must be delivered at RD ANF Peshawar within the time limit mentioned in the supply order at the cost of the supplier.
- i. No transportation and carriage charges will be paid for delivery / installation of the equipments.
- j. Income Tax & Sales Tax will be deducted at current prescribed rates.
- k. On supply, if any fault / defect occur it will be done / replaced by the Supplier.
- l. An affidavit to the effect that the firm has never been indulged in any litigation and has never been blacklisted by any Ministry / Division / Department / Organization of the Government(s).
- m. The bid with the lowest cost conforming to the specifications and other conditions prescribed in tender documents will be considered for placement of Supply Order.
- n. The bid must accompany a refundable call deposit @ Rs. 2% in the shape of Bank Draft / Pay Order in favour of Director, RD ANF Peshawar.
- o. Rates / quotations must be valid upto **30 June 2025**.
