Sui Northern Gas Pipelines Limited (SNGPL) is the largest integrated natural gas company of Pakistan. SNGPL intends to pre-qualify contractors for acquiring various services of Distribution Department at Islamabad Region for three years, which includes ditching & reinstatement for laying of different diameter pipelines (both polyethylene & Steel), ditching for laying of service lines of different diameter pipes for provision of new gas connections, construction of valve pits, ditching and backfilling for different maintenance / operational activities, cleaning, coating and wrapping of steel line pipe, welding & fusion of steel & polyethylene pipe and provision of skilled and unskilled labour, like mason, meter mechanic, grinder man, fitter & welder etc.

It is pertinent to mention here that TORs/SOP for pre-qualification of contractors has been revised and a fresh pre-qualification of contractors has been initiated for hiring of services for distribution activities in Islamabad Region as per revised TORs/SOP.

The pre-qualification of contractors will be undertaken in Islamabad Region and contractor/firms can purchase tender documents from the Islamabad Regional Office where they are interested to participate for pre-qualification. The contractors already stand pre-qualification with the company in Islamabad Region are also required to participate in fresh pre-qualification failing which their previous pre-qualification will be treated canceled.
