- 6. Items for S. No. 1 to 5 (Goods) shall be purchased on quoted rates up to 30.06.2025.

INSTRUCTIONS FOR BIDDERS:-

- 1. Rates should be quoted serial-wise as per tender document (s) inclusive of GST (where applicable). Income Tax withholding will apply as per prescribed rates. Rates excluding of taxes, will not be considered.
- 2. Sealed bids should reach in the office of the undersigned upto 22.07.2024 at 10:30 AM. The tenders will be opened by the Departmental Purchase Committee (DCP) in the presence of bidders or their representatives at 11:00 AM on the same day, at Conference Hall, Ground Floor, Regional Tax Office, Tax House, Rawalpindi.
- 3. A firm can apply for one or multiple items keeping in view its expertise and capacity to supply / delivery.
- A Pay Order of Rs. 50,000/- in favor of "Drawing & Disbursing Officer, RTO-4. Rawalpindi" should be attached with bid as security (refundable).
- 5. The Services of Air Conditioner Mechanic, Electrician cum Plumber and Janitorial Staff will be required during the office hours, even on extended working hours.
- 6. For provision of services mentioned at S. No. 6 to 8 (against Services), the agreement will be executed initially for a period of one year (from 01.10.2024 to 30.09.2025), which may mutually be extended further, on the same terms and conditions. However, the agreement can be terminated by either party through one (01) month written notice, in advance.
- 7. The DPC may reject all bids or proposals at any time prior to the acceptance of a bid or proposal under Rule-33 of the Public Procurement Rules.
- 8. In case of shortfall in supply / services during the year / agreement, the bid security will be forfeited, in favor of Government and firm will be blacklisted, alongwith any other punitive measures that may be taken.
- 9. The samples of rates quoted items should be provided with quotation.
- 10. The supplies would have to be according to specifications / samples as approved by the DPC.
- 11. Incomplete bids / offers will not be considered, in any case.
