The tenders must be received in the office of the accepting officer by **1130 hrs** on **13 Sep 2024** and tender will be opened on **13 Sep 2024** at **1200 hrs**.

NOTE: - Contractor shall provide certificate that they are not involved in any type of litigation with government department in the court of law and that no special report of Directorate of Inspection and Evaluation (E-in-C's Br GHQ Rwp) is outstanding against them.

6. Contractors who are desirous should be present at the time of opening of tenders.

7. The accepting officer reserves the right to accept or reject the tender, rejected tenders will be dealt with as per Para 33(i) of PPRA Rule.
