

1.1 Instruction to Bidder:-

- 1.2 All the bidders duly incorporated and based in Pakistan Governed by rules, laws and statutes of Government of Pakistan, CNIC holders, NTN holders shall be eligible
- 1.3 All bids must be accompanied by Earnest Money i.e. 5% of total bidding amount in respect of "NADRA NSRC DISBURSEMENT ACCOUNT". The bids along with Earnest Money, Bidding Documents, etc. must be submitted to Admin Branch, National Database and Registration Authority, Regional Head Office, Quetta on 8th October, 2024 not later than 11:00 AM

On same day, The bids will publicly be opened at RHO NADRA Quetta at 11:30 AM.

The bidder must submit bids on the basis of complete requirements as per bidding documents. Failure to meet this condition will cause disqualification of the bidder. The bidder shall submit bids which comply with the Bidding Document.

2. ELIGIBILITY AND QUALIFICATION CRITERIA

<u>AUCTION OF UNSERVICEABLE / SCRAPED ITEMS</u> (NADRA, RHO QUETTA)

- a. Sealed bids/offers are invited for the auction of condemn items. Bid containing necessary documents, CDR, Bidding Documents duly completed in all aspects shall be submitted by 8th October, 2024 at 11:00 am in the sealed envelope **Under Single Stage One Envelope Bidding Procedure** (Bid submit after due date shall not be entertained)
- b. The bids will be opened on 8th October, 2024 at 11:30 am at Regional Head Office NADRA, Zarghoon Road Quetta.
- c. All the condemned items to be disposed of on "As and Where It is Basis"
- d The interested parties can be visited RHO NADRA Zarghoon Road Quetta for inspection of disposal items from 23rd September to 7th October, 2024 between 10:00AM to 03:00PM except Saturday & Sunday in the presence of Auction Board.
- e. Bidder will have to deposit 5% of Quoted bid amount as Earnest Money (Refundable) through CDR/ Pay Order in respect of NADRA NSRC DISBURSEMENT ACCOUNT at the time of submission of bidding documents.
- f. Earnest Money will be released to un-successful bidder once bid will be awarded to successful bidder.
- g. Offers not supported by earnest money will not be entertained
- h. 25% amount of the total bid shall be paid / deposited by successful bidder in bank (NADRA Account) on same day as letter of acceptance received by procuring agency. Otherwise earnest money shall be forfeited. Moreover, 75% remaining amount shall be paid / deposited by the successful bidder within 24 working hours.
- i. WHT (10% for filer or 20 % for non-filer) shall be included in the offered bid.
- j. Bidder or representative may attend the opening of bid on due date.
- k. The highest bid (Lot Wise) above the reserve price will be accepted.
- I. Successful bidder shall also pay All Govt Taxes in addition to the total bid amount
- m. Successful bidder shall be responsible to pull out all items / equipment etc from Regional Head Office NADRA (Zarghoon Road Quetta) within 48 hours after complete payment by their own expense.
- n. If the successful bidder(s) fails to remove the stores within stipulated period, NADRA has the right to charge demurrage to the bidder @ 2% per day of the total bid amount.
- o. The competent authority reserves the right to reject all bids / tender without assigning any reasons as per PPRA Rule 33
- p. Bidder will submit copy of valid Computerized National Identity Card (CNIC).
- q. Cutting & over writing of bids will be liable to rejection.
- r. Bidder will submit the copy of National Tax Number (NTN).



- s. Bid with incomplete / fake supporting documents will not be entertained, and furnishing of incorrect information shall be liable to legal action.
- t. Declaration/Undertaking of Non-blacklisting and authenticity of all documents on Non-Judicial Stamp paper duly attested by oath commissioner / notary public to be attached (as per format attached in this bidding documents)
- u. NADRA employees and their flood relatives will not be allowed to participate in auction. Bidders will render a certificate to the effect that he has no blood relative/serving in NADRA. (Attached with tender form).
