USCP invites bids through E-PADS according to the Public Procurement Rules, 2004 from the financially sound, strong, stable transport companies / firms, registered with Income Tax / Sales Tax Departments and in the active taxpayers' list of the FBR at the time of opening of bids and having minimum / at least three years relevant experience, for the transportation of goods / items to be lifted from Warehouse and deliver to USC Stores located at **Multan, Khanewal, D.G.Khan, Bahawalpur, Bahawalnagar, Layyah, Muzaffargarh, Bhakkar & Vehari** and vice versa as and when required.

Sealed bids offer is invited under Rule 36 (a) "Single Stage One Envelope" of the Public Procurement Rules, 2004, for the transportation of stock / goods/ items.

Sealed bid must be submitted on E-PADS by **11th February, 2025 at 01:00 PM** which will be opened on the same day at **01:30 PM** through E-PADS. All interested bidders / suppliers must register themselves at E-PADS at <http://eprocure.gov.pk/#/supplier/registration> and submit their bidding documents; no physical bid shall be entertained. In case of opening of bids falls on local/national holiday, the date of bid closing/opening shall be the next working day on the same time and venue.

The bidders are required to give their best and final prices (including all applicable taxes) as no negotiation with respect to scope of work and pricing is allowed. Bids not complying with the requirements shall be rejected / disqualified being nonresponsive. Alternate/conditional/incomplete proposals shall be considered nonresponsive.

Taxes will be deducted as per applicable Government Rules. NTN and Sales Tax Registrations certificates must be provided with the Bid.

Bids which are incomplete/not sealed/not signed/not stamped/late or submitted by other specified mode will be rejected. The contract will be awarded to the most advantageous bid on lump sum contract region wise.

Bidding / Tender documents along with terms and conditions for bidding can be obtained electronically and can be downloaded from USCP website i.e. www.usc.org.pk as well as E-PADS PPRA website www.eprocure.gov.pk free of cost. Bidders need to be registered at E-PADS PPRA to access the bidding documents and other relevant information.

An affidavit on legal stamp paper worth **Rs.100/-** to the effect that the bidder has not been blacklisted by any Govt/Semi Govt/Autonomous Organization and there is no litigation lying pending adjudication in any Court of Law.
