Executive Engineer B&R Division C&W Department Ghanche invites sealed proposals (Technical & Financial) from engineering consultants/firm for the scheme "Feasibility study for construction of RCC Bridge Basho over Indus river, RCC Bridge HarbotRoundu, Asad Zaidi Shaheed Delta RCC Bridge over Indus river at PariKharmang, RCC Bridge Bilargo (Musa) in District Kharmang & RCC Bridge at Dumsum District Ghanche **Feasibility study and detail designing for construction of RCC Bridge at Dumsum District Ghanche**. The interested firms must have proven experience of feasibility studies and detail designing of RCC bridges on major rivers, detail designing of roads, highways and other allied structures.

The Firms must have a valid registration with PEC in the relevant field and code for FY 2024-25 (or as per extended period by PEC if any) and income Tax/services Tax registration with FBR along with proof of office Establishment branch in Pakistan. Interested firms may obtain the **RFP** documents from the office of the undersigned during office hours (0900 hours to 1600 hours) upon submission of non - refundable fee of Rs. 5000/- up to 14th November, 2024.

The bidder should visit the project site to get acquainted with the existing conditions and to get familiar with the quantum of work and nature of assignment. A joint visit to the project site can be arranged on request.


A pre-bid meeting will be held on 12-11-2024 in the office of the Executive Engineer B&R Division C&W Department Ghanche at 11 am. Single Stage-Two envelope procedure will be adopted as per **GB-PPRA Rule 2022 39 (b)**. One envelope containing technical proposal should be clearly marked as "**Technical Proposal**" and the second envelope containing the financial proposal should be clearly marked as "**Financial Proposal**".

The envelope of "**Financial Proposal**" should be accompanied with an amount of Rs. 0.200 million as bid security in the form of Deposit at Call in favor of Executive Engineer B&R Division C&W Department Ghanche.

Partial and incomplete bids will not be considered. "Technical Proposal" and "Financial proposal" (both envelopes) are to be submitted at the address mentioned below by 28th November, 2024 at 10:00 am at the office of Executive Engineer B&R Division C&W Department Ghanche. The envelopes containing the technical proposal shall be opened at 10:30 am on the same day in the office of the Executive Engineer B&R Division C&W Department Ghanche in the presence of those bidders who choose to be present. Proposals received after the prescribed time and date shall be rejected. The envelope of "Financial Proposal" of the firms who fail to technically qualify shall be returned unopened.

The envelope of "Financial Proposal" of only "Technically Responsive & Qualified Firms" will be opened in the presence of their respective representatives at the date and time to be determined and communicated later.

All the applicable Federal / Provincial taxes must be considered while preparing the Financial Proposal and are required to be built in the quoted rates and not be mentioned separately. Provision of forged, fake, false, unsubstantiated, incomplete information may lead to deduction of marks and disqualification and /or blacklisting.
