**[DASU HYDROPOWER PROJECT, WAPDA]**

1. The Dasu Hydropower Project, WAPDA has sufficient funds from its own resources/the Government of Pakistan /International Financial Institute towards the expenditure of the provision of LPG Cylinders for Office Building and Officer's/ Official's Accommodations at Dasu, District Kohistan Upper, and intends to apply part of the proceeds toward payments under the contract for **“Supply of LPG Cylinders for Office Buildings and Officer's/Official's Accommodations at Dasu, District Kohistan Upper”**.
2. The Dasu Hydropower Project, WAPDA intends to prequalify suppliers for Invitation to Bid(s), and sign the framework agreement(s) with the selected bidder(s) subsequent to bidding process in case of **Closed Framework Agreement(s)**.
3. The objective of the intended Closed framework agreement(s) is the on-demand supply of LPG Cylinder for Office Building and Officer's/Official's Accommodations at Chuchang, Tehsil Dasu, District Kohistan Upper through subsequent Call-off Contract(s) with successful bidders, and the purpose of this Prequalification Notice is to provide the very basic information to enable the potential applicants to decide whether or not to respond to this Prequalification Notice.
4. Only the prequalified applicants shall be entitled to participate in the procurement proceedings, and it is expected that the Invitation to Bids will be made to the Prequalified Applicants within a month of conclusion of pre-qualification and Closed Framework Agreement(s) will be signed b/w the Procuring Agency and the successful bidder(s) as Framework Agreement Suppliers after conclusion of bidding process for the period of Eight Months.
5. Prequalification process is open for all National Applicants subject to fulfilling the eligibility requirements mentioned in the respective Prequalification Documents. Interested Applicants may obtain further information from the office of GM/PD, Dasu HPP at the address mentioned below during office hours i.e. **0830 to 1630 hours**.

A complete set of Prequalification Documents in English may be obtained from the office of Director (Services) under General Manager / Project Director Office by interested Applicants on the submission of a written Application and upon payment of a non-refundable fee of Rs. 1000/- in the shape of Cash Deposit/Pay Order in the name of General Manager/PD, Dasu Hydropower Project, Dasu, Kohistan. The documents will be provided directly to the Potential Applicants, and essential record shall be maintained by the Procuring Agency for providing information regarding amendment(s), if any, in Prequalification Documents.
7. Applications for Prequalification should be submitted in clearly marked envelopes and delivered to the address mentioned below latest by **11:00 AM on January 15, 2025**. Late Applications will be rejected.
