- Available Budget is Rs.1,500,000/-. Payment will be made as per available/released budget.
- 6. Tender must be accompanied by a Bank Draft/Pay Order of 2% i.e. Rs.30,000/- of quoted value in favor of Chief Commissioner Large Taxpayers Office, Multan as earnest money, otherwise tender shall be rejected.
