2. The contractors are required to submit their application for issuance of tender documents alongwith their credentials as shown at serial (3). The application shall be scrutinized and the tender documents will only be issued to the firms who have sufficient experience in the relevant field and satisfy other special conditions required for the job and area. Tenders will only be issued to the scrutinized contractors. The tenders must be received in the office of the Accepting Officer by **1130 hours on 10th Mar 2025** and tender will be opened on **10th Mar 2025 at 1200 hours**.

3. Firms / Contractors not borne on approved list of MES will furnish a certificate alongwith their applications, giving details of works executed during last two years and those in hand on the proforma appended below:-

4. All contractors will certify in writing that they are registered with Pakistan Engineering Council (PEC), and will submit a copy of their registration. Contractors not registered with PEC are ineligible to apply.

5. Contractor born on approved list of MES in Category 'A', 'B', 'C', 'D' & 'E' and also having experience of this type should only apply.

6. Contractor who desire may be present at the time of opening of tenders.

7. The accepting officer reserves the right to accept or reject the tender, rejected tenders will be dealt with as per Para 33 (i) of PPRA Rules.
