## **TENDER NOTICE**

1. Central Directorate of National Savings (CDNS), invites e-Bids through PPRA e-Pak Acquisition & Disposal System (EPADS) to hire the services of an experienced and well-reputed Firm, licenced by Security & Exchange Commission of Pakistan (SECP), registered with Tax Authorities, Employees Old Benefit Institute (EOBI) and Social Security Institutions (SSI) and having valid No Objection Certificate (NOC) of Ministry of Interior and Provincial Home Department(s) and membership with All Pakistan Securities Agencies Association (APSAA) for provision of Security Guards for the period of three (03) years to more than 421 offices across the country including Head Office, Islamabad and field offices/ branches.
2. The detailed Bidding Document, which will be the integral part of this Tender may be obtained from the undersigned during office hours or can be downloaded from [www.savings.gov.pk](http://www.savings.gov.pk) or [www.ppra.org.pk](http://www.ppra.org.pk).
3. The Tender shall be carried out under Rule-36(b) (Single Stage-Two Envelope) of Public Procurement Rules, 2004. Bidders are required to submit their bids through PPRA-EPADS ([www.eprocure.gov.pk](http://www.eprocure.gov.pk)), however, the bid security in original amounting to Rs.500,000/- in shape of Pay Order / Demand Draft / CDR / Cashier Cheque/ Bankers Cheque only, issued from any bank operating in Pakistan in favour of Director General, CDNS, Islamabad must be delivered on below mentioned address before bid submission date & time. Bids must be submitted on or before **11<sup>th</sup> March, 2025 upto 11:00 a.m.** Bids will be opened on the same day at 11:30 a.m. at Conference Room of Central Directorate of National Savings (CDNS), 23-N, Savings House, Civic Centre, G-6 Markaz, Islamabad in the presence of the bidders or their representatives who wish to attend the proceedings.
4. The CDNS reserves the right to reject any / all or a part of bids prior to the acceptance of a bid or proposal, for which reason (s) may be conveyed if desired in writing as per PPRA Rule-2004.

# **INSTRUCTIONS TO THE BIDDERS**



## **SECTION I - INSTRUCTIONS TO BIDDERS (ITB)**

### **1. Scope of Bid.**

Central Directorate of National Savings, having its principal place of business at 23-N, Savings House, G-6 Markaz, Islamabad hereinafter called the “Central Directorate of National Savings” or “CDNS” or “Procuring Agency”, issues this Tender Notice to invite Proposals (Technical & Financial) under Rule-36(b) (Single Stage-Two Envelope) of Public Procurement Rules, 2004 from well reputed Private Security Firms licenced by Security & Exchange Commission of Pakistan (SECP), registered with Tax Authorities, Employees Old Benefit Institute (EOBI) and Social Security Institutions (SSI) of respective province and having valid No Objection Certificate (NOC) of Ministry of Interior and Provincial Home Department(s) and membership with all Pakistan Securities Agencies Association (APSAA) for provision of Security Guards to more than 421 offices across the country including Head office, Islamabad and field offices/ branches as prescribed in Part-II of the Bidding Document.

### **2. Eligible Bidders.**

Only well reputed Private Security Firms, licenced by Securities & Exchange Commission of Pakistan (SECP), registered with Tax Authorities, Employees Old Benefit Institute (EOBI), Social Security Institutions (SSI), and having valid No Objection Certificate (NOC) of Ministry of Interior and Provincial Home Department(s) and membership with all Pakistan Securities Agencies Association (APSAA) can participate in the bidding process. Bidder who has violated the law of land of any country and recorded in any sanctions list or blacklisted by any authority/ organization will not be eligible to participate in the bidding/ procurement process.

### **3. One Bid per Bidder.**

Each Bidder shall submit only one bid; a bidder who submits or participates in more than one Bid will cause all the proposals with the Bidder’s participation to be disqualified.

### **4. Bid Validity.**

The period of Bid validity shall be 180 (one hundred eighty days) after the deadline for Bid submission. The Contract “will not” be subject to price adjustment except in case of any tax duty or levies or minimum wage imposed by the Government of Pakistan during the currency or execution period of the contract.

### **5. Earnest Money / Bid Bond /Bid Security.**

Bid Security amounting to PKR 500,000/- (Rupees Five hundred thousand only) is required in original in shape of Pay Order / Demand Draft / CDR / Cashier Cheque/ Bankers Cheque only, issued from any bank operating in Pakistan in favour of Director General, CDNS, Islamabad must be delivered on the mentioned address before bid submission date & time.

### **6. Cost of Bidding.**

The Bidder shall bear all costs associated with the preparation and submission of its bid, and CDNS will in no case be responsible or liable for those costs.



**7. Clarification of Bidding Document.**

A prospective Bidder requiring any clarification regarding Bidding Document may contact the Procuring Agency through EPADS. In accordance with provision of Rule 31 of PPRA Rules, 2004, if a Bidder feels that any important provision in the Bidding Document is unacceptable; such an issue should be raised at-least seven days before bid submission.

**8. Deadline for submission.**

The deadline for submission of Bids shall be **11<sup>th</sup> March, 2025 up to 11:00 a.m.**

**9. Bids Opening.**

Bids will be opened at 11:30 a.m. on same day at CDNS Conference Room in the presence of the bidders or their representatives who wish to attend the bid proceedings.

**10. Method of Bid Submission.**

The Proposals must be submitted online through PPRA EPADS ([www.eprocure.gov.pk](http://www.eprocure.gov.pk)) as per schedule i.e. on **11<sup>th</sup> March, 2025 upto 11:00 a.m.** Bidding process will be carried out as per Rule-36(b) (Single Stage-Two Envelope) of Public Procurement Rules, 2004.

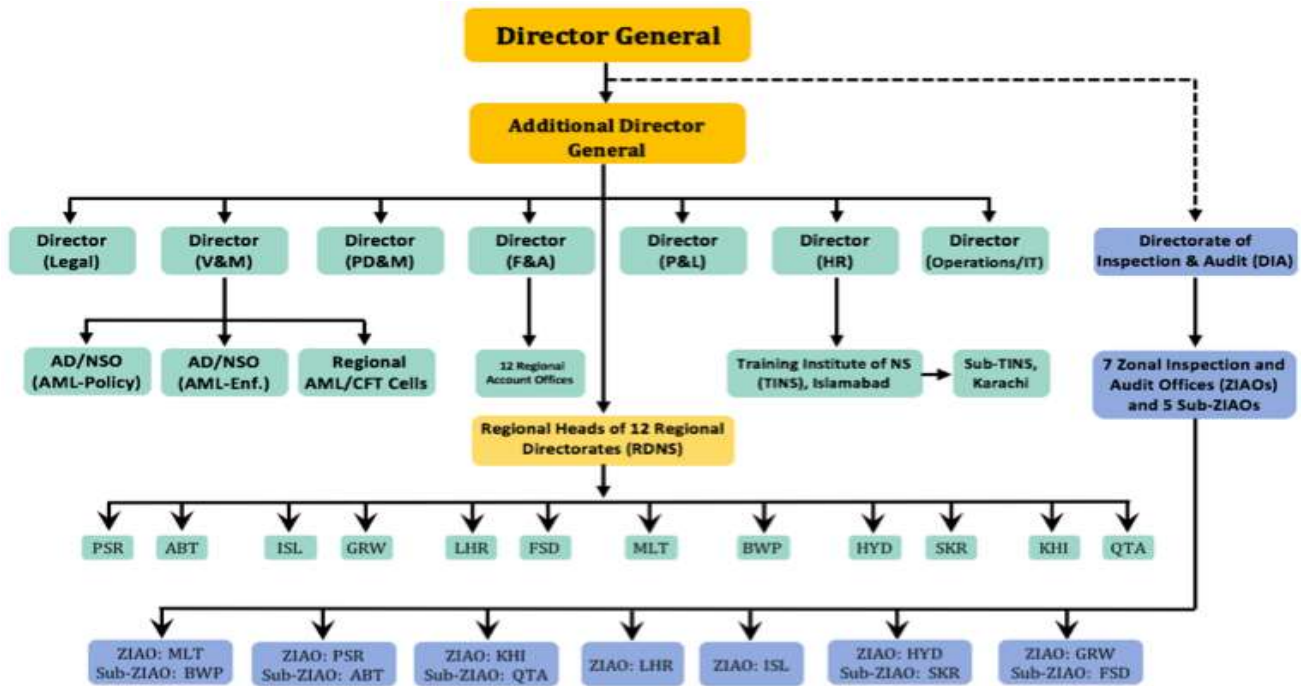


## SECTION II – INTRODUCTION TO ORGANIZATION

### 11. Introduction

11.1. CDNS is defined as an Attached Department of Finance Division as per Schedule III of Rules of Business, 1973 (issued by Federal Government in exercise of the powers conferred by Articles 90 and 99 of the Constitution of the Islamic Republic of Pakistan). Key Role of CDNS is to formulate policies on National Savings Schemes (NSSs) and offer it to public under following administrative infrastructure. There are more 351 NSCs across the county which offer these products to public.

11.2 Administratively, CDNS and its offices are distributed into twelve Regions i.e. Regional Directorates of National Savings (RDNS), Abbottabad, Bahawalpur, Faisalabad, Gujranwala, Hyderabad, Islamabad, Karachi, Lahore, Multan, Peshawar, Quetta & Sukkur. Furthermore, there are 12 Regional Accounts Offices, 12 Zonal Inspection & Audit Offices, 13 National Savings Treasuries, 02 Training Institutes, Directorate of Inspection & Audit, Islamabad working under CDNS. Organogram of the Organization is display below:



11.3 CDNS is currently managing portfolio of more than PKR 3.3 trillion and clientele of more than 4 million through above mention branch network across the country. More than 10 National Savings Schemes are offered to clients whereas numbers of new schemes are in progress.



### **SECTION III – DESCRIPTION OF SERVICES**

#### **12. Description of Services**

- 12.1 The Procuring Agency through this tender intends to hire services of a well reputed Private Security Firm, licenced by Securities & Exchange Commission of Pakistan (SECP), registered with Tax Authorities, Employees Old Benefit Institute (EOBI) and Social Security Institutions (SSI) of respective province and having valid No Objection Certificate (NOC) of Ministry of Interior and Provincial Home Department(s) and membership with all Pakistan Securities Agencies Association (APSAA) for provision of approximately **1150-1250** Security Guards to more than 421 office across the country including Head office, Islamabad and field offices/branches. Province wise detailed lists is as annexed as **Annex-A** alongwith tentative number of required guards.
- 12.2 Following type of Security Guard would be required:
- Retired personnel from Armed Forces, Para Military Forces, Rangers, Police or any other law enforcement agency.
  - Properly Trained Civilians: Qualified from recognized institutions.
- 12.3 There shall be preferably two (02) Guards in day time duty and one (01) guard at night time at each location i.e. NSC / Office on shift basis (08 Hours as per requirement of Procuring Agency).
- 12.4 Security guards should be equipped with following type of weapons and instruments or any other type as required by the law enforcement authorities during duty time;
- 01 Guard, armed with Automatic Assault Rifles, (preferably AK-47 or equivalent) with at least two Magazines (fully loaded) however, in case of non-availability of desired number of automatic rifles, magazine fed semi-automatic assault rifles may be used with at least two Magazines (fully loaded) along with sufficient reserve ammunition.
  - 01 Guard, armed with Pump Action, 12 Gauge gun, with 20 cartridges
  - 01 Guard, armed with 9MM Gun (semi-automatic) with at least 30 rounds and Hand Metal detector.
  - In addition to above, fully functional “High Voltage Stun Gun” for National Savings Treasury Vans carrying cash.
- 12.4 The Security firm shall provide proper uniforms/ complete kit (having company name and logo/ monogram on shirt) alongwith other equipment’s to the Security Guards as per standard norms of provisioning of such type of security services in a professional manner.
- 12.5 The Security Guards to be deployed shall be physically, mentally & medically fit, vigilant & literate and shall be of age **25 to 55** years.

## **SECTION IV – BID SUBMISSION AND EVALUATION CRITERIA**

### **13. Bid Submission Criteria**

- 13.1 Technical Bids should be prepared in an organized manners divided into section/ chapters with proper referencing as per the Responsiveness Test / Initial Screening and Technical Evaluation Criteria.
- 13.2 Each criteria of the Technical Bid must be substantiated with valid proof.
- 13.3 Non-compliance to Para 13.1 and 13.2 will lead to poor technical marking during technical evaluation.
- 13.4 False/ wrong or misleading information, if shared, may lead to disqualification of bidding firm from the tendering process.
- 13.5 Any attempt, directly or indirectly, to influence may lead to disqualification of bidding firm from the tendering process.
- 13.6 Support material should not be part of the main proposal but should be placed as Annexures.
- 13.7 Each page of bids (Technical & Financial) must be signed and stamped by authorized officer of Security Firm/ bidder.
- 13.8 Bid price should be inclusive of the following minimum requirements:-
  - Mimimum wage rate as set out by the Federal/ Provincial Governments
  - EOBI contribution
  - Social Security Contribution
  - Any other mandatory contribution, which are required as per law.
- 13.9 Bid prices which are below the mandatory payments as mentioned in clause 13.8 above shall be rejected straight away.

### **14. Responsiveness Test / Initial Screening**

- 14.1 Prior to the Technical Evaluation, all the Technical Bids shall be examined for the Responsiveness Test / Initial Screening on the basis of parameters listed as under. Non-compliance to these parameters shall disqualify the bidder.
  - A. The Bidder is licensed or registered with following authorities/ organizations:
    - I. Security & Exchange Commission of Pakistan (SECP) as Security Company (Provide SECP Registration Certificate).
    - II. Tax Authorities with Income Tax status as “Active” and Sales Tax as “Operative” (Provide relevant Certificate).
    - III. Employees Old Benefit Institute (EOBI) and Social Security Institutions (SSI) of respective province (Provide the EOBI & SSI Registration Certificates).
    - IV. Valid No Objection Certificate (NOC) of Ministry of Interior and Provincial Home Department(s) (Provide the copies of requisite NOCs).
    - V. Membership with All Pakistan Securities Agencies Association (APSSA) (Provide the copy of APSSA Certificate)
  - B. The Bidder has been in this business for at least 5 years.
  - C. Have offices in ICT and Provincial Capitals i.e. Lahore, Karachi, Quetta and Peshawar.
  - D. Affidavit on stamp paper of Rs.100/- signed by bidder and duly attested by Notary Public/ Oath Commissioner, describing that bidder is not blacklisted from any government department and no suit is pending against the bidder(s) in any court of law or any case/ litigation.



E. Bid Security as an earnest money of required amount i.e. Rs.500,000/- must be submitted to the Procuring Agency before the opening of Bids.

**16. Technical Evaluation and Acceptance Criteria.**

16.1. As per PPRA Rule 36(b) Single Stage-Two Envelope bidding procedure, the proposals will be evaluated technically first. Each technical criterion shall be assessed separately and marked according to the provided evidences. Total technical scores will be the sum of all the individual scores assigned to each of technical criteria. The bidder who gets minimum **70% marks i.e. 42 out of 60 in Technical Evaluation** will qualify for the next stage of tendering process only.

16.2. The Technical and Financial Proposals shall be allocated **60:40 weightage** each. Financial bids of only technically qualified bidders will be opened. The distribution of 100 marks and formula of financial bids evaluations will be as follows:

b. Financial bids shall be evaluated as per following formula:

***Financial marks = Bid Ratio x 40 (Weightage of financial bids)***

16.3. The cumulative effect of both Technical and Financial marks shall determine the position of the bidders. The contract may be awarded to the bidder whose bid is found as the most advantageous on the basis above evaluation.

## **SECTION V: GENERAL TERMS & CONDITIONS**

### **17. Validity of proposal**

All proposal/bids and prices shall remain valid for a period of at least 180 days from the closing date of the submission of the proposal/bids.

### **18. Currency**

All currency in the proposal shall be quoted in Pak Rupees (PKR) only otherwise bids would be rejected.

### **19. Withholding Tax, Sales Tax and other Taxes/Levies**

Tax/ duties shall be deducted at the rate prescribed under the tax laws of Pakistan, from all payments for services rendered by any bidder who signs the contract with the Government. The bidder will be responsible for payment of all taxes/ duties on transactions and/ or income, which may be levied by government from time to time.

### **20. Contracting (Signing of Agreement).**

**20.1** The contract initially will be for the period of three (03) years extendable up to maximum of five (05) years (inclusive of initial contract period) on yearly basis upon satisfactory performance subject to the conditions that if both parties are willing to continue the contract on existing terms and conditions. However, the procuring agency reserves the rights to revoke the agreement any time after one year of contract on expiry of one (01) month Notice.

**20.2** The selected vendor will submit Contract Agreement, for which draft may be obtained from procuring agency, and be signed on a stamp paper of Rs.1,000/- (which shall be notarized properly) within reasonable time after the issuance of work Order/ letter of acceptance.

### **21. Governing Law**

This and any contract executed pursuant to this Bidding Document shall be governed by and construed in accordance with the laws of Islamic Republic of Pakistan. The Government of Pakistan and all bidders responding to this and parties to any contract executed pursuant to this shall submit to the exclusive jurisdiction to the Courts at Islamabad.

### **22. General Terms of the Agreement**

**22.1** Deployment of Security Guards is to be completed as per the plan mutually agreed upon between the contracting parties and from the date of acceptance of the offer by the bidder.

**22.2** The procuring agency may change the demand of number of guards for deployment at NSCs depending on the circumstance.

**22.3** All weapons would be mandatory to be test fired once in every two months, under proper supervision of security firm.

**22.4** It shall be the responsibility of the firm to submit test fire report duly verified by the Manager Level Executive of the firm along with a certificate that each weapon has been test fired by the concerned security guard.

**22.5** Any delay in deployment of guards over the stipulated period will attract penalty of Rs.5,000/- per guard (delay in deploying) per day.



- 22.6** Procuring Agency shall have the exclusive rights to surprise check the functionality of any weapon / instrument and the ability to operate the weapon by the concerned Guards. In case of any shortcoming, a penalty up to 0.5% of monthly invoice may be imposed by the Procuring Agency besides taking any other corrective measure.
- 22.7** The Security Guards to be deployed shall be physically, mentally & medically fit, vigilant & literate and shall be of age 25 to 55 years.
- 22.8** The Security firm shall provide proper uniforms/ complete kit (having company name and logo/monogram on shirt) and equipment/ weapons with valid license to the Security Guards along with necessary ammunition/ cartridges/ hand metal detector to the entire satisfaction of procuring agency and as per standard norms of provisioning of such type of security services in a professional manner.
- 22.9** It shall be mandatory for the Security Firm to get the Police Verification report and all other security clearance reports, required under relevant Laws & Regulations, in respect of all deployed security guards. Such reports shall be readily available with the Firm. Procuring Agency shall have the rights to demand such reports about any Guard at any time. Non-availability of such record may invite the penalty as defined in Clause 24.6.
- 22.10** The Security Guards shall also hold original Computerized National Identity Card (CNIC) as well as Security Firm Identity Card issued by authorized officer/ department of Security firm, all the time during duty hours.
- 22.11** The security firm should perform its business/ duties in line with guidelines/ SOPs of relevant Law Enforcement Agencies, Ministry of Interior, Provincial Home Departments or any other legitimate entity/organization/ department etc. under the Laws of Pakistan.
- 22.12** The duty time of the Armed Security Guards will be 8 hours per day on shift basis as per requirement of the procuring agency in proper uniform for Full month (*including weekends & holidays*).
- 22.13** The security firm should maintain the attendance and leave register of the guards which will reconcile with the officer concerned of procuring agency regularly.
- 22.14** The Security firm shall arrange a proper and regular mechanism to supervise the security guards deputed at the premises of procuring agency all the times and ensure that their personnel are performing their security duties efficiently, vigilantly, honestly and in the most substantial manner required by their profession and in every other respect strictly in accordance with the directions and instructions of the procuring agency and as per Standards Norms for doing same business in Pakistan. Such supervisory visit reports, duly verified and countersigned by the Officer Incharge of the concerned NSC or the authorized officer by Procuring Agency for other offices, shall be submitted to the Regional Directorate concerned.
- 22.15** The Security firm shall ensure that the security guards deployed by it, should maintain perfect discipline, behavior, attitude, respect of customers/ citizens and do not in any manner cause any interference, annoyance, nuisance for the procuring agency or its business/affairs.





- 22.16** The Security firm will not disclose to a third party/irrelevant entities/peoples any information regarding the security arrangement of the procuring agency including but not limited to the assignment instructions, schedules and other subsequent arrangements entered into with the procuring agency either in writing or verbally.
- 22.17** The Security firm shall be bound to depute another security guard at the premises with immediate effect in substitution of security guard who is dismissed by the Security firm or has proceeded on leave or is missing without leave or to leave his place of duty due to unavoidable circumstances.
- 22.18** The Security firm will be responsible for the timely payment and rights and liabilities of the security guards in accordance with the applicable labour law for the time being enforced in Pakistan.
- 22.19** The Security firm will at its own discretion, obtain life insurance cover for its security guards and shall take all other necessary steps to ensure that procuring agency is not liable for any loss to the security guards or to any of his belongings under any circumstances whatsoever.
- 22.20** The security guards provided by the security firm must be well trained in the areas: how to react in normal situation, critical situation, alertness, handling of weapons, public safety, routine maintenance and checkup of weapons as per standard practices etc.
- 22.21** The security firm will provide the proof of salaries paid to the guards via bank accounts as and when require by the procuring agency.
- 22.22** The security firm will be responsible for the increase/ decrease in the tax rates by the Government.
- 22.23** Any increase/ decrease in the minimum wages by the Federal / Provincial Governments would be incorporated/ materialized by the procuring agency in light of the instructions issued by the Public Procurement Regulatory Authority, Islamabad vide letter No.1/481/2024/LEGAL/PPRA dated 20.12.2024.
- 22.24** Procuring agency reserves the rights to revoke the agreement any time on expiry of one (01) month's Notice.
- 22.25** The procuring agency will be free to either reduce or increase the number of armed guards to be deployed on the same terms and conditions during the contract period.
- 22.26** In between the contract period if the procuring agency is allotted new work order for deployment of armed guards, maximum time for deployment would be fifteen (15) days or the order will be cancelled.
- 22.27** The security firm will submit an un-conditional and irrevocable Performance Bank Guarantee ("PBG") equal to 05% (Five percent) of total contract price, valid for total contract period from the date of deployment of security guards and subsequent resubmission/ renewal for each extended year as the case may be. The PBG shall be submitted on or before raising first invoice for payment.
- 22.28** Payments shall only be made on monthly basis at Central Level subject to submission of invoices alongwith evidences of the following compliances:



- **Minimum Wage compliance as set out by the Federal/ Provincial Government from time to time.**
- **Registration with EOBI of each and every deployed Guard and submission of EOBI Contribution.**
- **Registration of Social Security Institution of each and every deployed guard and submission of SSI Contributions.**
- **Compliance with another rule/ law as required by any Government authority or organization.**

**22.29** The Security firm will be responsible for the payment of the monthly salaries to the Security Guards upto 5<sup>th</sup> of the each month positively, in case of any failure, penalty up to 0.5% of monthly invoice may be imposed by the procuring agency besides taking any other corrective measure.

**22.30** The EOBI and SSI Contributions will be deposited in the accounts of the EOBI and SSI and copy of receipt must be provided alongwith monthly invoices.

**22.31** The procuring agency may proceed with blacklisting of the security firm in case of gross violation of the terms and condition as per defined procedure of the Government.

**22.32** The security firm will provide the information i.e. list of guards containing their CNIC, EOBI & SSI registration numbers and any other information alongwith the Bidding Document as well as and when required by the procuring agency. However, the procuring agency reserves the right to stop the payment of security firm in case of non-provision of information or any other non-compliance.

**22.33** The Procuring Agency reserves the right to forfeit the Performance Bank Guarantee upon poor performance or non-compliance of agreement and terminate the contract. However, upon successful completion of contract/ termination of the contract, the Performance Bank Guarantee may be released accordingly.

### **23. Disclosure/ Integrity Pact**

**23.1** The security firm hereby declares that it has not obtained or induced the procurement of any contract, right, interest, privilege or other obligation or benefit from Government of Pakistan (GoP) or any administrative subdivision or agency thereof or any other entity owned or controlled by it (GoP) through any corrupt business practices.

**23.2** Without limiting the generality of the foregoing the firm represents and warrants that it has fully declared the brokerage, commission, fee etc. paid or payable to anyone and not given or agreed to give and shall not give or agree to give to anyone within or outside Pakistan either directly or indirectly through any natural or juridical person, including its affiliate, agent, associate, broker, consultant, director, promoter, shareholder, sponsor or subsidiary, any commission, gratification, bribe, finder's fee or kickback, whether described as consultations fee or otherwise, with the object of obtaining or inducing the procurement of a contract, right, interest, privilege or other obligation or benefit in whatsoever form from GoP, except that which has been expressly declared pursuant hereto.



**23.3** The security firm will certify that it will make full disclosure of all agreements and arrangements with all persons in respect of or related to the transaction with GoP and has not taken any action or will not take any action to circumvent the above declaration, representative or warranty.

**23.4** The security will firm accept full responsibility and strict liability for making and false declaration, not making full disclosure, misrepresenting fact or taking any action likely to defeat the purpose of this declaration, representation and warranty. It will agree that any contract, right interest, privilege or other obligation or benefit obtained or procured as aforesaid shall, without prejudice to any other right and remedies available to GoP under any law, contract or other instrument, be voidable at the option of GoP.

**23.5** Notwithstanding any rights and remedies exercised by GoP in this regard, the firm will agree to indemnify GoP for any loss or damage incurred by it on account of its corrupt business practices and further pay compensation to GoP in an amount equivalent to ten time the sum of any commission, gratification, bribe, finder's fee or kickback given by supplier as aforesaid for the purpose of obtaining or inducing the procurement of any contract, right, interest, privilege or other obligation or benefit in whatsoever form GoP.

**24. Force Majeure**

A "Force Majeure Event" shall mean act of God or any event or circumstance or combination of events or circumstances that are beyond the control of a Party and that on or after the date of signing of this Agreement, materially and adversely affects the performance by that Part of its obligations or the enjoyment by that Party of its rights under or pursuant to this Agreement; provided, however, that any such event or circumstance or combination of events or circumstances shall not constitute a "Force Majeure Event" within the meaning of this Section to the extent that such material and adverse effect could have been prevented, overcome, or remedied in whole or in part by the affected Party through the exercise of due diligence and reasonable care, being understood and agreed that reasonable care includes acts and activities to protect the Sites and the Facilities, as the case may be, from a casualty or other reasonably foreseeable event, which acts or activities are reasonable in light of the likelihood of such event, the probable effect of such event if it should occur and the likely efficacy of the protection measures. "Force Majeure Events" hereunder shall include each of the following events and circumstances that occur inside or directly involve Pakistan, but only to the extent that each satisfies the above requirements:

- Any act of war (whether declared or undeclared), invasion, armed conflict or act of foreign enemy, blockade, embargo, revolution, riot, insurrection, civil commotion, act or campaign of terrorism, or sabotage;
- Strikes, works to rule or go-slows that extend beyond the Sites, are widespread or nationwide;
- Change in Laws of Pakistan;
- Other events beyond the reasonable control of the affected Party, including, but not limited to, uncontrollable events, namely, lightning, earthquake, tsunami, flood, storm, cyclone, typhoon, or tornado, epidemic or plague, radioactive contamination or ionizing radiation;



## **25. Amicable Settlement**

- 25.1** Any dispute, controversy or claim arising out of or relating to this Contract, or the breach, termination or invalidity thereof, shall be resolved through negotiation in an amicable and friendly manner between the parties. The Parties shall seek to resolve any dispute amicably by mutual consultation and discussion at the appropriate level of Parties or through the committee constituted, representing members from both sides, whichever is suitable to reach the amicable solution of dispute.
- 25.2** If either Party objects to any action or inaction of the other Party, the objecting Party may file a written Notice of Dispute to the other Party providing in detail the basis of the dispute. The Party receiving the Notice of Dispute will consider it and respond in writing within thirty (30) days after receipt. If that Party fails to respond within thirty (30) days, or the dispute cannot be amicably settled within thirty (30) days following the response of that Party, disputes shall be settled by arbitration in accordance with the following provisions:
- 25.3** Failing amicable settlement, the dispute, differences or claims, as the case may be, shall be finally settled by binding arbitration in accordance with the provisions of the Arbitration Act 1940 of Pakistan.
- 25.4** The arbitration shall be conducted at Islamabad, Pakistan before an arbitration panel comprising three (3) members, one to be nominated by each Party and the third nominated by the first two nominees (collectively, "Arbitration panel").
- 25.5** The fee/expenses of the arbitrators and all other expenses of the arbitration shall initially be borne and paid equally by both the Parties, subject to determination by the arbitration panel. The arbitration panel may provide in the arbitral award for the reimbursement to the prevailing party of its costs and expenses in bringing or defending the arbitration claim, including legal fees and expenses incurred by such Party.
- 25.6** Any decision or award resulting from the arbitration shall be final and binding upon the Parties. The Parties will agree that the arbitral award may be enforced against the Parties to the arbitration proceedings or their assets, wherever they may be found, and that a judgment upon the arbitral award may be entered in courts having jurisdiction at Islamabad only.
- 25.7** Pending the submission of and/or decision on a dispute, difference or claim or until the arbitral award is published the Parties shall continue to perform all of their obligations under the Contract.
