1. Tenders will be opened on “Single Stage Two Envelop “bidding procedure basis”.
2. The price should be firm and final on FCS basis and without involving any foreign exchange
3. Registered / Non-registered firm with DISCO/ NTDC/WAPDA can participate.
4. The bid is valid for a period of 90 days.
5. Tender must be accompanied with Bank Guarantee amounting to Rs.1 million against Tender No. 225,0.2 million against Tender No. 226 and 0.4 million against Tender No. 227 in favor of Chief Executive Officer IESCO Islamabad valid for 120 days (One hundred & twenty days) in the form of Bank Guarantee/Call Deposit issued by any schedule Bank of Pakistan (having rating A+ or above). Moreover, Bid Security must be attached with Technical bid.
6. Tender forms including terms and conditions can be obtained from the office of Material Management IESCO Islamabad against non-refundable amount Rs.3,000/- per tender on any working day during office hours till a day earlier from the date of opening of tenders.
7. In case of holiday announced by the Govt of Pakistan, strike in IESCO or any other reasons whatsoever due to which this office remains closed on the above schedule tender opening date, the tender will be opened on next working day at same time and place/venue.
