Whereby the bid will comprise of single package containing two separate sealed envelopes, one envelope will contain the "Technical Proposals" and the second envelope will contain the "Financial Proposals" as the case may be, and Tender No:1/01/A-BIS/2025/LOG/PSDP being clearly written on the top of the respective envelope and both 'Technical and Financial Proposal'.
- v. In the first instance, Technical Proposals shall be opened by a committee on Tuesday 08 April, 2025 (03:30PM) in the Conference Room of this office. After technical evaluation, Financial Proposals of only technically qualified companies shall be opened on a date/time to be announced subsequently.

A tender security of fixed amount in original with specified in bidding document for Hardware & Software LOT-01 to 04 must be attached with the Financial Proposal in the form of a Pay Order/Demand Draft/Bank Guarantee in favour of DGIP. Copy of bid bond will be attached with technical proposals.
