- 3. The electronic Pre-qualification documents / proposals must be submitted by using E-PADS on or before 15-07-2024 at 11:00 AM which will be opened on the same day at 11:30 AM through E-PADS. All interested bidders must register themselves at E-PADS at http://eprocure.gov.pk.
- Applications, which are incomplete/not signed/not stamped/late or submitted by other than specified mode will be rejected. The contract will be awarded to the most advantageous bid.
- Tender must be accompanied by a Bank Draft/Pay Order of 2% of quoted value in favor of Chief Commissioner Large Taxpayers Office, Multan as earnest money, otherwise tender shall be rejected.
- 6. The bidders shall be on Active Taxpayer List (ATL) and shall be regular Sales Tax return filer. (Where applicable).
- 7. Bidder firm shall attach an affidavit of Rs.100/- on stamp paper (latest and Original) to the effect that the firm has not been black listed by any of the Govt. Departments.
- 8. The quotations may be submitted inclusive of all taxes.
- Income Tax / Withholding Tax will be deducted in accordance with the law. Kindly note that the Sales Tax (if applicable) shall also be deducted in accordance with the law.
