- Photocopy of valid CNIC.
- Undertaking on Non-judicial stamp paper of Rs. 100/- certifying that owner / plot is not temporary / permanently
 debarred from any Government agency / authority / department (without bearing any responsibility on NADRA
 whatsoever in this regard).
- Pictures of the plot offered for purchase.
- In case of absence of owner, authority letter for representative duly signed by property owner, permitting him to attend tender process.
