#### TERMS AND CONDITIONS

- Bidders should provide the name of firm, complete postal address, Telephone No, Email address and web address (if any).
- Bidders are required to upload their bids on EPADS systems as per laid down PPRA procedure for two stage two envelope method.
- The bid security in shape of pay order (5% of total bid) must be submitted at the address given in tender notice at the time of opening date & time else tender will not be accepted.
- 4. The bidder/firm/company/individual will submit an affidavit on stamp paper of Rs. 50/- that their firm has not been blacklisted in the past on any ground by any Government (Federal, Provincial), a local body or a public sector organization. On account of submission of false statement, the bidder will be debarred from bid. The said stamp paper will be submitted in original at the time of opening.
- 5. Bids will be opened in the office of Additional Registrar (Procurement) Health Services Academy Islamabad in the presence of the Vendors or their representatives who wish to be present. The Two Stage – Two Envelope procedure will be adopted for opening of competitive Bids.
- Absence of bidder or their representative shall not impair the legality of the opening procedure. All the present Bidder(s) or their representative shall be required to sign on attendance sheet.
- 7. Quoted rates will be evaluated as per our demand & terms and conditions.
- 8. Bidders shall not be permitted to withdraw their offer or modify the terms and conditions thereof. In case the bidder fails to observe and comply with the stipulations made herein or backs out after quoting the rates, the aforesaid 'Bid Security' shall be forfeited in the favor of Health Services Academy.
- 9. The Most Advantageous Bid would be accepted.
- 10. The bids should be accompanied by an Original Bid Security of 5% of the total bid in the form of Pay Order/CDR/ Demand Draft of any commercial bank. The Pay Order/CDR/ Demand Draft shall be drawn in favor of "Health Services Academy" which will be returned immediately after the completion of tendering process to the unsuccessful bidders and after satisfactory completion of delivery/supply to successful bidder (s) respectively.
- 11. The bids without Earnest Money shall be rejected. Original pay order of Bid Security must reach before the closing date and time of tender otherwise the bid/s will be rejected.
- 12. Bidder(s) are required to submit the all the mandatory documents as per rules of PPRA/EPADS. The company / firm must be active taxpayer and register with regulatory bodies preferably Security Exchange Commission Pakistan (SECP).
- 13. The items must be delivered within one month from the issuance of the purchase order. in case of delay in supply, a penalty of 1% of the total bid amount will be charged on a weekly basis.

- 14. The procuring agency reserves the right to increase or decrease the quantities of items depending upon the availability of budget and need/requirement.
- 15. Incomplete bids / conditional bids will be liable for rejection.
- 16. Refurbished/Used systems shall not be accepted in any case.
- 17. The supplied Items as per demand will be checked by our Technical Committee and if found otherwise will be rejected at once and the earnest money will be forfeited and blacklisting of the stated vendor be acted upon as per PPRA rules and laws.
- 18. All the bids must be inclusive of all government taxes.
- Most Advantageous bidder will be required to deliver items within (01) week after issuance of Purchase Order.
- 20. Warranty of the items will start from the date of delivery.
- 21. Competent Authority reserves the right to reject all bids or proposal any time prior to the acceptance of a bid or proposal in the light of PPRA rules.
- 22. All the information provided by the bidder must be verifiable.
- 23. If the 1<sup>st</sup> lowest evaluated/ Most Advantageous bidder fails to sign the contract/ receive purchase order/deliver the items then the bid money will be confiscated by the Health Services Academy. Accordingly, the old Purchase order will be cancelled and new Purchase Order will be issued to the 2<sup>nd</sup> lowest Evaluated Bidder/2<sup>nd</sup> Most Advantageous bidder with approval of the Competent Authority, as per PPRA rules.
- 24. The selected entity shall enter into a formal agreement with HSA outlining the terms of the responsibilities and arrangements.
- 25. The Procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal.
- 26. The bids (both Technical and Financial cum project proposals) should be submitted in separate envelopes (only for EPADS registered entities) through EPADS.
- 27. The vendor will deliver and install the machinery and make functional at the site (district) communicated Via HSA.
- 28. HSA can increase or decrease the quantity as per requirement.
- 29. The entity shall comply with all relevant laws, regulations, and standards governing in Pakistan.

The copy of the bank draft shall be attached with the proposal and uploaded on EPADS. (Original bank draft must be submitted at the time of bid opening).

The payment will be made to the supplier on receipt of original invoice (s) including of GST/NTN (if applicable) duly completed in all respect. The bills should be received through relevant department of Health Services Academy Islamabad. Each bill must contain detail of items. Income tax will be deducted from each invoice as per government instructions on the subject.

#### **Submission Format:**

- Sealed bids are invited from well reputed organizations / companies / individuals having valid GST & NTN registered with respective regulatory bodies preferably Securities & Exchange Commission of Pakistan (SECP) FBR, PPRA etc and being active tax payer having relevant experience.
- Submit the bid electronically through PPRA online portal i.e. EPADS as per the instructions given by the PPRA.
- The bids (both Technical and Financial cum project proposals) should be submitted through EPADS under Two Stage Two Envelope bidding procedure.

#### Content of Bid:

- Provide a cover letter expressing interest in the project and briefly outlining the vendor's expertise and experience in relevant field.
- Include a detailed company profile highlighting past projects and any relevant certifications or accreditations.
- Clearly articulate the proposed concept, scope, and objectives for the facility, including services offered.
- Include a financial proposal detailing cost estimates of items mentioned at Annexure-I.
- Provide references and testimonials from previous clients.

 Await notification from the HSA regarding the outcome of the bid review process and any subsequent steps, such as shortlisting or further discussions.

#### Note:
