Electronic Request for Proposal document containing detailed requirements, terms & conditions is available for the registered bidders on EPADS at www.eprocure.gov.pk. The quoted rates /bids shall be valid upto 31-12-2025. (Complete detail of equipment along with technical specifications is given in tender document.)

Bidders who may fulfill and abide by the prescribed terms & conditions contained in tender document may submit their bids (technical and financial in separate envelopes) on using E-PADS portal and also submitted hard copy in the office of Director Procurement, PARC, HQs, as per format on or before 09-04-2025, by 1100 hours positively and bids will be opened on the same day at 1130 Hours at PARC HQ in presence of bidders or their nominated representatives who choose to be present. No tender will be sold on date of opening of tender.

4. Each bid should be accompanied with 2% earnest money of quoted bid amount in shape of bank draft or pay order in favor of PARC, Islamabad. The conditional bids/T&C or the bids without earnest money or containing less earnest money shall not be accepted as per PPRA Rules.

5. The payment of all GST/applicable taxes is the responsibility of the firms/companies. PARC reserves the right to reject any or all bids proposals prior to acceptance of a bid or proposal. However PARC shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of bids / proposals, but is not required to justify those grounds.
