- 3) Tender forms including terms and conditions and detailed specifications can be obtained from the office of Chief Engineer (MM) IESCO Islamabad against non-refundable amount of Rs.2000/- per tender on any working day during office hours till a day earlier from the date of opening of tender.
- 4) Written application on company letter head along with copies of registration with sales tax department (STRN), NTN # etc. should be produced at the time of issuance of tender documents / bid schedule.
