GENERAL TERMS AND CONDITIONS.

- 1. Earnest money as mentioned above must be attached with the tender documents in from of demand draft/pay order in the name of DFO/DDO, Gilgit-Baltistan Forest Division Hunza from any schedule bank.
- 2. Tender with incomplete supporting documents shall not be accepted and furnishing of incorrect information shall be liable to legal action. All bids/ quoted rates shall be submitted in typed shape.
- 3. An affidavit on stamp paper of Rs. 100/- must be accompanied with the tender documents to the effect that the bidder has never been balk listed by any Government/Semi-Government organization/PPRA.
- 4. The firm/contract winning the bid shall be bound to supply the items to Forest Division Hunza till 30th June, 2025.
- 5. The tender shall be considered lot wise and firm shall be bound to supply/provide goods/services at rates quoted in tender during the financial **year 2024-2025**.
- 6. Firms quoted inappropriate rates with respect to market rates shall not be considered.
- 7. The contractor must have its own shop/ workshop to participate in the Tender.
- Firms/Contractor must have minimum five (05) year experience in the relevant filed can only participate
 in tender and supply orders/experience certificate/proof of experience must be attached with tender
 documents.
- 9. Contractor/Firm for supply of private vehicles must have sufficient fleet of vehicles dully registered/indexed with Excise & Taxation Department and owned office/shop.
- 10. Firm having their own shop/workshop/partnership/mutual work agreement shall have to provide proof of their own workshop/shop at Gilgit shall have to provide JV/partnership/mutual working agreement on stamp paper of Rs. 100/- duly signed by both parties. No photocopy shall be accepted. In case of mutual work agreement proof ownership of shop/workshop of 2nd party shall be mandatory.
- 11. Bank statement of last three years would be required with closing balance of at least Rs. 1.5 million.
- 12. Tender documents containing detail of evaluation criteria, items, work and specification may be obtained from the office of the undersigned during office hours before date and time of closing mentioned above.
- 13. The department reserves right to accept or reject the tender according to PPRA rule-33(1).
