1. The National Highway Authority intends to hire/ engage a Consultant (Engineering Organization/ Firm) for Consultancy Services for Feasibility Study and Detailed Design for Improvement and Widening of (N-5) 813 KM.

Proposals are invited from reputable Consultants (Engineering Organizations/ Firms) having valid Pakistan Engineering Council (PEC) registration certificate in relevant field alongwith enlistment on active Tax Payer List of Federal Board of Revenue and the detail eligibility criteria mentioned in the RFP documents.
