

INSTRUCTION TO BIDDERS / TERMS & CONDITIONS / BIDDING DOCUMENTS as per (RULE 23(2) (whichever applicable) OF PPRA RULES, 2004

- The Bidders / Firms should be financially sound, have sufficient experience, well reputation and capacity for timely completion of paint work, have own offices / stores with telephone facilities.
- 2. A certificate to the effect that the firm has never been indulged in any litigation and has never been blacklisted by any Procuring Agency of Governments must be attached with the bids.
- 3. The bidders must attach proofs of registration of their firms in the FBR regarding NTN / General Sales Tax Registration Number and Active Taxpayers. Telephone / fax numbers must be printed on the quotation / bills of the competing firms as AGPR does not accept claims without this requirement.
- 4. Copy of CNIC of owner of the firm must be attached with the bid.
- 5. Conditional, incomplete or ambiguous bid (s) will not be accepted.
- Earnest money (bid security) (Rs.100,000/-) must be attached with bids in the shape of Pay Order in favor of DDO, SPHQ, Karachi. The bid security will be returned to unsuccessful bidders immediately after finalization of the tender process.
- 7. The Organization reserves the right to increase / decrease the volume / quantity of work, reject all bids in the light of Rule-33 of PPRA Rules-2004.
- 8. Substandard items / work will be rejected and necessary steps will be taken against the firm.
- The bidders may give their best and final prices inclusive of all Levi-able taxes, laborer charges, freight etc. as no increase in the prices could be allowed at later stage.
- For proper work / "value for money", ICI Dulux, BERGER, GOBIS...... or equivalent paints will be used.
- 11. The paint work will be executed on per square feet rate which will include laborers' cost, cost of other material and minor repairs (scrapping / sand papering / cleaning the old surfaces / filling the holes, cracks, unequal surfaces with wall putti etc. including primer coat, single, double or three coats, where

- required). For roofs, matt emulsion will be used while on walls and doors, matt enamel of desired colors and specific types shall be used.
- 12. Each bid shall comprise one single envelope containing, separately, financial proposal and technical proposal, if any.
- 13. Successful bidder (s) will be required to execute agreement governing the terms & conditions of the contract.
- 14. Covered Area of Building proposed for renovation / repaint is approximately 200,000 sq. ft involving estimated cost of Rs.4.1 Million.
- 15. Bids will be valid for 60 days from the date of opening of bid.
- 16. The successful bidder will furnish performance guarantee in the shape of bank guarantee of his bank which shall be 8% of the contract amount as specified under Rule 39 of PPRA Rules, 2004 on the name of DDO, SPHQ, Karachi.
- 17. After completion of work, Inspection shall be carried out by the procuring agency and both parties sign separate completion certificates.
- 18. In case, any of the term and condition of the agreement is violated, the responsibility for loss or damage will be borne by the firm.
