- 2. Interested firms with relevant experience should apply to the undersigned and the tender will only be issued to the owner of firm or having the authority from owner/CNIC/Income tax/Sale tax certificate and proof of not being blacklisted.
- 3. The complete tender documents will be submitted back to the Planning & Development Director by <u>---</u> <u>13<sup>th</sup> June 2025</u> at 12:00 pm.
- 4. The Bidding shall be held as **a single stage** Two envelops procedure as per PPRA rules.
- 5. Technical proposal will be opened at 12:30 pm on the same date in front of LUAWMS committee as well as the bidders.
- 6. Financial documents of the technically qualified firm(s) will also be opened on the same day/date or any other working day with prior information to technically qualified firms.
- 7. Financial bids must be accompanied by an earnest money @ 5% of bid cost in the shape of Call Deposit from a scheduled Bank of Pakistan in favor of Director P&D LUAWMS-Uthal and tender found without 5% Earnest money will be rejected forthwith.
- 8. The bidder who withdraws (at tender opening occasion) or modifies his tender after submission, his earnest money will be forfeited. No conditional tender will be entertained under any circumstances.
- 9. After final award, the successful bidder(s) will be liable to complete the supply within stipulated period as per specification given in tender documents. In case of cancelation of supply order due to default of the firm, the earnest money shall be forfeited in favor of LUAWMS, Uthal.
