Request for Proposal for providing maintenance and support services for Database & Software applications.

Employees' Old-Age Benefits Institution (EOBI) intends to hire services of a software/technology firm for the maintenance and support of its in-house applications for two years extendable up to one year on the same terms and conditions. The project will be titled "Maintenance, Support, and enhancement for Software and Database". Bids are invited from reputable firms to undertake the project in an efficient/timely manner and as per bid documents. Bidding will be conducted according to Rule 36(b), Single Stage Two Envelope procedure of PPRA Rules 2004 and is open to all bidders who meet the following *eligibility criteria*:

- i. The bidder is a registered firm under the Companies Act 2017 and is operating in Pakistan for at least five years.
- ii. Must be in the latest active taxpayer list of FBR.
- iii. The bidder must have completed at least two projects of database and software development/support/maintenance during last five years.
- iv. The bidder should have, at least, an average annual revenue of Rs. 200 million during the last five years.
- v. The bidder must not be in litigation with EOBI and Federal/Provincial Governments and has not been blacklisted by the Federal and/or Provincial Governments or law courts in or outside Pakistan.
