- i. An affidavit on stamp paper of Rs. 100/- that the firm has never been indulged in any litigation and has never been blacklisted by any Ministry/Division/Department/Organization of the Government(s).
- ii. Attested copy of certificate of registration of Income Tax and Sales Tax.
- iii. Procurement of consultants is based on Quality & Cost Based Selection (QCBS) Method under Single Stage Two Envelopes (SSTE) bidding procedure.
- iv. Pay Order/Demand Draft of Rs.100,000/- as security money for one year in favor of Federal Government Employees Housing Authority from any scheduled Bank. (Refundable to unsuccessful bidders).
