1. INTRODUCTION

PAEC Foundation Invites Expression of Interest (EOI) for prequalification from competent, qualified and well-experienced Consultants / Consulting Firms / companies for provision of Services for **review and enhance amenities of its Housing Scheme** namely “**PAEC Foundation Housing Project**” situated in Lahore for optimal satisfaction of the community. The services are required to ensure the project’s compliance with legal and regulatory standards and to optimize its potential.

2. SCOPE OF WORK

The consultant will be required to perform the following tasks:

Planning Services:

- i. Review existing master plan for the Housing Scheme.
- ii. Obtain necessary approvals from relevant regulatory bodies for revised plan.

Projection Services:

- i. Develop a strategic marketing plan to promote the project.
- ii. Identify target markets and devise effective outreach strategies.
- iii. Provide recommendations for branding and customer engagement.

3. ELIGIBILITY CRITERIA (MANDATORY)

Interested consultancy firms must meet the following criteria:

- i. **Registration with Relevant Authorities:** Firms must be registered with professional bodies such as the Pakistan Council of Architects and Town Planners (PCATP), Pakistan Engineering Council (PEC), or other recognized authorities relevant to the scope of work.

5. EVALUATION CRITERIA

I. Firm's Experience and Past Performance: 50 marks.

Evaluation will base on the firm's track record, relevance of completed projects, and client satisfaction.

- 5 Years' Experience: 20 Marks
- Each Project Completed: 05 Marks (Maximum: 30 Marks)

II. Financial Capacity: 10 marks.

Assessment will focus on the firm's ability to mobilize resources, manage budgets, and meet technical demands.

- Avg. Annual Turn Over: 25 Million 10 Marks
(Last 3 Years):
If less than 30 Million, then 2 marks will be given for each 5 Million.

III. **QUALIFICATION AND EXPERIENCE OF PROPOSED TEAM MEMBERS:**

Maximum Marks: 25 marks.

Points will be awarded based on the qualifications, certifications, and relevant experience of the proposed team members.

Marketing Expert: 15 Marks

- MBA Marketing: 02 Marks
- Certification: 03 Marks
- Experience : 10 Marks
(Each year of Experience having 2 Marks)

Town Planners: 10 Marks

- Relevant Degree registered with relevant authority: 02 Marks
- Experience : 08 Marks
(Each year of Experience having 2 Marks)

IV. **Quality of Proposed Methodology and Work Plan: 15 marks.**

The methodology will be evaluated on its feasibility, clarity, and alignment with project objectives.

Note: Minimum Qualifying Marks is 75

If no one obtains 75% marks, then qualifying marks will reduce to 65%
