- 1. Pay order/bank draft/banker's cheque of amount Rs. 2000/- (non-refundable) in the name of Director General PITAC, Lahore, must be submitted along with bid as Tender participation Fee.
- Bidding will be conducted under National Competitive Bidding Procedure as per the provisions of Public Procurement Rules-36(2) <u>Single stage – two envelopes</u> procedure.
- 3. Bids may be submitted as per conditions set out in bidding documents electronically through federal PPRA EPADS web portal http://eprocure.gov.pk before closing time & date. Manual bids shall not be accepted. Supporting documents can be sent in hard copy. The bids shall be opened on the same day at 11:30 AM.
- 4. Scanned copy of Bid Security of Rs. 200,000/- in the shape of deposit at call or a bank guarantee issued by a scheduled bank in the name of Director General PITAC, Lahore be sent through EPADS, while the original Bid Security must be dispatched to the undersigned. Bid, without earnest money will be rejected. Earnest money of successful bidder will be retained for the whole period of contract.
- 5. The bids of any bidder shall be declared non-responsive, if he is found involved in litigation with any government or semi-government department.
- 6. The bidders should be on active taxpayers list of FBR. Valid copies of Company Registration, Income Tax and Sales Tax Registration Certificates will be attached.
- 7. PITAC reserves the right to reject all bids as per rule 33 PPRA 2004.
- 8. Quoted rates/price shall remain valid for a period of 01 year.
- 9. The firm has to submit an **affidavit on Stamp Paper**, being not blacklisted from any Govt. Department.

- 11. Further, personal convincing, recommendation or unauthorized practices for getting the Contract, will also disqualify the bidders.
