- MEPCO invites sealed bids on **Single Stage-Two Envelope** bidding procedure, from eligible firms under National Competitive Bidding (NCB) basis in accordance with Provisions of PPRA Rules.

ELIGIBILITY CRITERIA

- This Invitation for Bids is open to all Bidders complying the following requirements: -
- Pakistan Engineering Council valid certificate with at-least Category **C-5** having Specialization Code **CE-10** must be provided.
 - Participation in at least two contracts that have been successfully completed within the last ten (10) years and that are similar to the proposed scope of work (The bidder will submit completion certificate of the projects along-with supporting documents).
 - The contractors are required to submit their registration for sales tax with Punjab Revenue Authority.
 - Identity Card of Contractor / Managing Partner / Director of the firm.
 - Bidding documents will be issued only to the owner of the firm OR representative holding authority letter of the firm.
 - Income Tax Returns** for last two years.
- Eligible Bidders may obtain further information, inspect and acquire the Bidding Documents from the Office of **Project Director (GSC) MEPCO, Multan up-to 12.06.2024** for tender.
- A complete set of Bidding Documents may be purchased by any interested bidder, meeting with the eligibility / qualification criteria, on submission of a written application to the above office and upon payment of a non-refundable fee of **Rs. 3,000/- (Rupees Three Thousand Only)** for each tender.
- All bids must be accompanied by a Bid Security amounting to **Rs. 1,050,000/-** in favor of **Project Director GSC MEPCO** of any scheduled bank and shall be valid 28 days beyond bid validity. The bid shall be valid for 150 Days.
