- 2. All terms and conditions of procurement processes guidelines issued by the Works Secretariat vide Notification No.Sec-SO-D-9(28)/2022-23/475 dated 26th January, 2023 and PEC bidding documents shall be part of procurement.

Rates quoted below 10% of the Technical Sanction shall be considered as unworkable; however, The bidder quoting rates below 10% of TS shall be required to provide along-with his bids an additional performance guarantee of 50% of the differential amount (between TS and Bid) in shape of CDR/Bank Guarantee from any schedule Bank or Guarantee bond from any AA Rating Insurance Company duly certified/vetted by the Head office of the Insurance Company. 4.
