- Electronic bidding documents as per regulations, containing detailed terms and conditions, specifications and requirements etc are available for the registered bidders on EPADS at www.eprocure.gov.pk.
- Applications should be submitted electronically only through E-PADS. Manual submission of Applications is not allowed.
- The electronic Pre-qualification documents / proposals must be submitted by using E-PADS on or before **14-06-2024 at 11:00 AM** which will be opened on the same day at 11:30 AM through E-PADS. **All interested bidders must register themselves at E-PADS at <http://eprocure.gov.pk>.**
- Applications, which are incomplete/not signed/not stamped/late or submitted by other than specified mode will be rejected. The contract will be awarded to the most advantageous bid.
- Tender must be accompanied by a Bank Draft/Pay Order of 2% of quoted value in favor of Chief Commissioner Large Taxpayers Office, Multan as earnest money, otherwise tender shall be rejected.
- The bidders shall be on Active Taxpayer List (ATL) and shall be regular Sales Tax return filer. (Where applicable).
- Bidder firm shall attach an affidavit of Rs.100/- on stamp paper (latest and Original) to the effect that the firm has not been black listed by any of the Govt. Departments.
- The quotations may be submitted inclusive of all taxes.
- Income Tax / Withholding Tax will be deducted in accordance with the law. Kindly note that the Sales Tax (if applicable) shall also be deducted in accordance with the law.
- All Proposals should include:
 - Company's profile, list of such projects handled, list of clients with telephone numbers and addresses;
 - Copies of Income Tax and Sales Tax registration certificates;
- Bidder (s) who does not qualify cannot challenge the findings of the evaluation or ask for reasons of disqualification.
- The procuring agency reserves the right to accept or reject any or all bids/proposal in accordance with Rule 33 of PPRA Rules, 2004.

- Bidders can participate in all or in a single LOT separately.
