Large Taxpayers Office, Multan invites electronic bids in accordance with the Public Procurement Rules 2004, from experienced and reputable firms having valid registration with tax and other relevant authorities, for procurement of Goods & Hiring of Services as mentioned below. The firms submitting their bids must be appearing on Active Taxpayers Lists of Income Tax & Sales Tax issued by Federal Board of Revenue, Government of Pakistan.

Terms & Conditions:

- Electronic bidding documents as per regulations, containing detailed terms and conditions, specifications and requirements etc are available for the registered bidders on EPADS at www.eprocure.gov.pk.
- Applications should be submitted electronically only through E-PADS. Manual submission of Applications is not allowed.
- 3. The electronic Pre-qualification documents / proposals must be submitted by using E-PADS on or before 14-06-2024 at 11:00 AM which will be opened on the same day at 11:30 AM through E-PADS. All interested bidders must register themselves at E-PADS at http://eprocure.gov.pk.
- 4. Applications, which are incomplete/not signed/not stamped/late or submitted by other than specified mode will be rejected. The contract will be awarded to the most advantageous bid.
- 5. Tender must be accompanied by a Bank Draft/Pay Order of 2% of quoted value in favor of Chief Commissioner Large Taxpayers Office, Multan as earnest money, otherwise tender shall be rejected.
- 6. The bidders shall be on Active Taxpayer List (ATL) and shall be regular Sales Tax return filer. (Where applicable).
- 7. Bidder firm shall attach an affidavit of Rs.100/- on stamp paper (latest and Original) to the effect that the firm has not been black listed by any of the Govt. Departments.
- 8. The quotations may be submitted inclusive of all taxes.
- Income Tax / Withholding Tax will be deducted in accordance with the law. Kindly note that the Sales Tax (if applicable) shall also be deducted in accordance with the law.
- 10. All Proposals should include:
 - i) Company's profile, list of such projects handled, list of clients with telephone numbers and addresses;
 - ii) Copies of Income Tax and Sales Tax registration certificates;
- Bidder (s) who does not qualify cannot challenge the findings of the evaluation or ask for reasons of disqualification.
- 10. The procuring agency reserves the right to accept or reject any or all bids/proposal in accordance with Rule 33 of PPRA Rules, 2004.
- 11. The advertisement is available for the registered bidders on E-PADS at www.eprocure.gov.pk & FBR's website (www.fbr.gov.pk).
- 12. Bidders can participate in all or in a single LOT separately.
