# Section: II Instructions to Bidders (ITBs)

## A. INTRODUCTION

1. Scope of Bid	1.1	National Disaster Management Authority (NDMA) invites Bids for procurement of Collapsible Modular Frame Water Tanks as indicated in the Bid Data Sheet (BDS) and Section V - Technical Specifications & Schedule of Requirements. The successful Bidders will be expected to deliver the Items and other requirements within the specified period and timeline(s) as stated in the BDS. The firms will also be asked to provide sample for evaluation, later on. The delivery time must be mentioned in financial proposals, alongwith cost of each item.
2. Source of Funds	2.1	National Disaster Management Fund.
3. Eligible Bidders	3.1	A Bidder may be natural person, company or firm or public or semi-public agency of Pakistan. In the case of a joint venture, consortium, or association, all members shall be jointly and severally liable for the execution of the Contract in accordance with the terms and conditions of the Contract.
	3.2	The invitation for Bids is open to all prospective supplier, manufacturers or authorized agents/dealers subject to any provisions of incorporation or licensing by the respective national incorporating agency or statutory body established for that particular trade or business.
	3.3	<ul> <li>A Bidder shall not have a conflict of interest. All Bidders found to have a conflict of interest shall be disqualified. 	4.2	For purposes of this Clause, "origin" means the place where the goods are mined, grown, cultivated, produced, manufactured, or processed, or through manufacture, procession, or assembly, another commercially recognized article results that differs substantially in its basic characteristics from its imported components or the place from where the related services are/to be supplied. The nationality of the supplier that supplies,

		assembles, distributes, or sells the goods and services shall not determine the origin of the goods.
