## **TENDER NOTICE**

Online/Electronic tenders are invited through web portal (<a href="https://etender.mlc.gov.pk">https://etender.mlc.gov.pk</a>) accompanied by earnest money in shape of deposit-at-call, in favour of Executive Officer, Lahore Cantonment based on MES Schedule of Rates 2021 (as amended up-to-date) for the following Original Works, to be executed during the current fiscal year 2024-2025.

**CONDITIONS:** - The general conditions will be as under:-

- 1) Interested bidders can only submit their bids online through E-Tender Portal of ML& C Dept. (https://etender.mlc.gov.pk).
- 2) Contractors having valid NTN No, and registered with PEC in the relevant category & limit are eligible to apply.
- 3) The cut off time for submission of online bids will be 1200 hrs dated 13 1 06 12025 and shall be opened on same day at 1230 hrs electronically on the portal. The contractors will be able to see the comparative statement online.
- 4) E-tenders without attachment of call deposit / bond in favor of the undersigned as earnest money will be rejected.
- The CDR's/Bid Security/earnest money (fixed amount) uploaded online shall also be deposited (in original) in LCB office (CB Care Centre) on the same day prior to cut off time in shape of demand draft/CDR/Pay order before opening of bids as per PPRA Rule No.25. In case of failure the bidder shall not be qualified for bid opening and shall be liable to face the consequences of forfeiture and blacklisting for sabotaging the tendering process.
- 6) The bid security/earnest money of successful bidder will be refunded after expiry of defect liability period i.e. 01 year after completion of work OR successful completion of audit which ever later.
- 7) In case if the lowest bid is less than reasonable rates (15% below the ruling %age as circulated by E-in-C's, latest) the lowest bidder shall have to deposit performance guarantee (refundable after successful completion of the work) 6% of bid amount in the shape of Bank Guarantee from any Schedule Bank in Pakistan or insurance bond from reputed insurance company which shall be got approved from the LCB (in addition to earnest money) within 07 days after issuance of acceptance letter as per PPRA Rule,39. In case of failure the already deposited earnest money shall be forfeited and tender will be cancelled.

- 11) The issuance of work order shall be subject to completion of all codal procedures i.e. (Sanction of CFA, approval of rates by the Board and availability of funds etc).

12) Request of contractor for issuance of work order on the basis of any plea will not be entertained.

13) Any information regarding the E-Tender can be obtained from the office of undersigned during office hours. Furthermore, guidance tutorial has been uploaded on the portal.

14) No cheque/cash will be acceptable.

15) Conditional/multioptional tender/quotation will not be accepted.

16) All PPRA Rules and Govt taxes (in vogue for the time being) are applicable.

17) Any tool/machinery kind of store /mobilization advance for execution of job will not be provided by LCB.

18) Escalation clause and secured advance are not applicable / admissible.

19) Overall rate of bid will be considered as lowest instead of single item rate.

- 20) Rates should be quoted on the basis of MES Schedule of Rates 2021 (amended up to date) for scheduled items and market rates for non-scheduled items.
- 21) The cost of making any test shall be borne by the contractor as MES specification/requirement.
- 22) For Tubewells & filtration plants, contractors are required to produce/submit purchasing order from original manufacturer (Registered with PEC & Enlisted with E-in-C Branch) regarding all the machinery/equipments.

23) Payment will be made after verification of all equipments from the manufacturer at site as per specifications and all the expenses (if any) will be borne by the contractor.
