1. The Local Govt. & Rural Development Department ICT, invites bids on Above/ Below basis for the following works from the firms/contractors must Registered with Pakistan Engineering Council (PEC) upto June, 2025 having relevant category and specialized code, those who possess lower category PEC registration and absence of required specialized code may not submit any bid, (be aware that such bids will not be considered / opened) and also registered on E-PAD as per Government Directions, for the financial year 2024-25.
2. The bidders/contractors/firms will submit bid till 10.06.2025 at 11:00 AM and will be opened on same day 10.06.2025 at 11:30 AM in the office of Executive Engineer LG&RD, ICT in presence of the Tender Opening Committee and contractors or their representative who may present at the opening date and time. Any Bidders/Contractors/Firms uploaded same CDR for more than single scheme will be considered false entry & bid can be rejected.
3. The interested bidders/contractors/firms can obtain the Tender Documents through E-PAD/ PPRA Web Site and should upload their bid through E-PAD. Manual bid is not acceptable.
4. The bidder/contractors/firms are also bound to submit original CDR 3% of the Estimated Cost in the office of the Executive Engineer LG&RD, ICT before the closing date and time. Otherwise, the firm/contractor bid will not be opened.
5. Notification of the GRC constituted in terms of Rule 48 of PPRA Rules 2004 is provided on E-PADS.
6. In case of any technical difficulty in using EPADS, prospective bidders may contact PPRA team, Director MIS Room No.109, 1st Floor FBC building Sector G-5/2 Islamabad Contact No. 051-111-137-237
7. There must be no cutting/ amendment in bid quoted by the contractors through electronic system. No telephonic/conditional Tender and without earnest money will be entertained.
8. Furthermore, information/detail scope of work and other conditions can be available in the office of Executive Engineer LG&RD, ICT on any working day during the office hours.
9. The firms/contractor shall be responsible for payment off all applicable taxes at the time of release of payment as admissible under the rules prescribed by the Government.
10. PPRA Rules will be strictly applicable. In case of any violation the contractor bid will be rejected according to the Rules.
11. Successful bidder shall be required to deposit a Performance Security equal to 10% of Estimated Cost as per relevant provisions of under PPRA rules.
